Answers

1. What were the judging criteria for the Positive Body Image Awards? Please provide a copy of the full criteria or guidelines for determining the recipients of the Awards.

Judging criteria for the Positive Body Image Awards were developed by the Assessment and Advisory Panel, based on the principles and guidance contained in the Voluntary Industry Code of Conduct for Body Image such as positive content and messaging, diversity, fair placement, realistic and natural images of people, healthy weight models, appropriate modelling age and include fashion retailers supporting positive body image.

There were two award categories for the Positive Body Image Awards:

- Positive Body Image business policies and practices: could be awarded to organisations which demonstrate a meaningful and ongoing inclusion of body image friendly principles (in line with the Voluntary Industry Code of Conduct for Body Image) within their business practices and policies; and
- Positive Body Image initiative or product: could be awarded for specific body image friendly initiatives or products (in line with the Voluntary Industry Code of Conduct for Body Image), such as a campaign to increase young people's media literacy about digital retouching or a body image friendly event or magazine special.
