#### Question

## FWO - relates to EW0181\_13 - Enforceable undertakings in respect of sham contracting

Senator ABETZ: Can I just confirm, for answer no. 181, that in 2010-11 no enforceable undertakings were entered into in respect of sham contracting. Mr Wilson: Yes, we can confirm that. Senator ABETZ: Were there any prosecutions that year? Mr Wilson: In sham contracting? Senator ABETZ: Yes. Mr Wilson: I believe so. Mr O'Shea: Which calendar year or financial year are you asking about? Senator ABETZ: 2010-11, referring to answer No. 181. Just going through it, I am not sure that I properly covered that. Mr Wilson: I think we should take that on notice. Senator ABETZ: Fair enough.

#### **Answer**

The Fair Work Ombudsman provided the following response.

The Fair Work Ombudsman (FWO) can confirm that in the 2010-11 financial year, no investigations were undertaken into sham contracting that resulted in an enforceable undertaking.

To be clear, one investigation into sham contracting that was undertaken in 2009/2010 resulted in an enforceable undertaking (EU) being entered into with Signature Portrait Studios Pty Ltd. The enforceable undertaking was entered into on 28 March 2011.
