Defence Housing Australia (DHA) undertakes marketing activity to promote its residential property investment program. Under this program, properties are sold to private investors and leased back to DHA to accommodate Australian Defence Force members and their families. Ongoing promotion is necessary to ensure sufficient gross demand is generated. Achievement of the program's revenue targets is crucial to the financial viability of DHA's operations.

A total of \$1,775,404 (rounded to the nearest dollar and including GST) was spent on promotion of the program during the period 1 July 2009 to 28 February 2010. This predominantly comprises press, radio and online advertising.
