Question 1

All programs Topic: Minister's travel costs Hansard, page 89

Senator KROGER asked:

I am happy to put these on notice, but it would be helpful if you could also undertake to provide a breakdown of costs for the minister, his staff, departmental staff including the ADC and any other member of the travelling party, including travel type, accommodation costs and travelling allowances paid for staff and departmental staff. If you could provide a copy of the minister's itinerary for each of those, that would be very helpful, and, if one exists, the itinerary for any other accompanying members on any of those trips.

Mr Campbell—By the way, the ADC is not a DVA departmental staffer; it is from the Department of Defence. As I said, for the trip that we are talking about here I have given you his party. Where there were departmental people in country they were not part of his party because they were not with him for the whole trip. I would also make the point I made right at the very beginning that much of the information you have asked for on travel is tabled every six months, I think, in the parliament, but I will go back to the minister and his office and seek details. I have taken it on notice.

Answer

Travel undertaken by the Minister for Veterans' Affairs is tabled biannually in the report, *Parliamentarians' travel costs paid for by the Department of Finance and Deregulation.* This report provides details of the dates and purpose of the travel, the countries of destination and the costs of visits.

With regard to departmental staff, an Aide-De-Camp (ADC) may accompany the Minister when he undertakes commemorative activities as part of his portfolio responsibilities.

Senate Question on Notice 1028 asked by Senator Ronaldson on 25 November 2008 and tabled on 16 March 2009 provided details of travel costs for the period 16 December 2007 until 14 November 2008.

Question 2

All programs Topic: 54/11 Rule Hansard, pp. 90 and 91)

Senator KROGER asked:

I was wondering how many of the DVA staff will reach the 54/11 cut-off before 30 June this year.

Mr Campbell — I think Ms Schumann can probably give you that figure, but I am not sure that your introduction is totally accurate. We are not experts on super, but I am ot sure that bureaucrats —

Senator KROGER — It was when the retirement age was lifted to 60.

Mr Campbell —Okay. Well, 54/11 is not a maximum superannuation payout for public servants, it is just that at 54/11 the pension is calculated in a different way than if you go at 60. Ms Schumann can give you the numbers.

Ms Schumann — Are you looking for the numbers of staff that are over 54/11—that are already 55?

Mr Campbell — Yes, I am.

Ms Schumann — I do not have the exact numbers by level here at this stage, but I can tell you the proportion. In terms of our overall staff numbers at 30 June last year, we had 2,061, and 47 per cent of those were over 50.

Senator KROGER — Forty-seven per cent were over 50. Do you have anything to indicate what those figures would be as of 30 June this year?

Ms Schumann — Not with me, no.

Senator KROGER — Could you take on notice a request to provide the proportion that you are referring to. I was wondering whether you could give me an indication of how much they would be financially disadvantaged.

Senator KROGER — I am interested in getting a breakdown of staffing levels by month and by the level.

Mr Campbell — We would have to take that on notice.

Answer

It is estimated that on current turnover levels (voluntary separations) that this number (staff aged over 50) will be 834, or 41.7% of total [actual] staff numbers as at 30 June 2010.

Of these 2061 staff, 262 were CSS members (i.e. for whom 54/11 is in some way relevant). Of the 262, 190 were aged over fifty and 97 of these were already fifty five or older, so the 54/11 situation is no longer applicable to them.

The are 165 CSS members in the Department under fifty five years of age who could potentially be impacted by the 54/11 rule. We are unable to determine whether these staff would be either financially advantaged or disadvantaged by this rule in the CSS as it will depend on their individual circumstances such as length of service and level of contribution.

Parliamentary Inquiry into RAAF F-111—Terms of reference

The committee will investigate and review claims for compensation from former F-lll deseal/reseal workers including the Commonwealth's response to the health and support needs of former F-lll Deseal/Reseal workers and their families. The Committee should ascertain whether the response was adequate, whether it was consistent with the findings of the Study of Health Outcomes in Aircraft Maintenance Personnel (SHOAMP) and whether the overall administration and handling of the program was adequate.

Terms of Reference:

The Inquiry will consider the adequacy and equity of the Health Care Scheme in meeting the health and support needs of participants and their families and whether this was consistent with the SHOAMP findings. Matters to be considered will include, but not be limited to:

- The differences, and transitional arrangements, between the interim health scheme and the final Health Care Scheme;
- The timing of cessation of access to the Health Care Scheme;
- The range of treatment and health benefits provided under the Health Care Scheme;
- Whether the current Health Care Scheme is consistent with the range of treatment and health benefits available to persons under other Health Care Schemes;
- The adequacy of arrangements under the Health Care Scheme affected family members (including widows) or serving members; and
- If the Health Care Scheme is not considered to be an adequate response to the health and support needs of participants and their families, consider and report on possible alternatives that are considered to be adequate in light of the findings of SHOAMP and other Health Care Schemes.

The Inquiry will consider the adequacy and equity of the financial element of the Ex Gratia Scheme and whether it was consistent with (i) the findings of SHOAMP, (ii) the Health Care Scheme response (iii) the Tier definitions, and

(iv) one off payments to other veteran groups. The Inquiry will consider, but not be limited to:

- Whether the lump sums available under the ex gratia scheme were appropriate;
- Whether the lump sums available were appropriate given the findings of the SHOAMP;
- Whether the lump sums, when considered along with the benefits available under the Health Care Scheme, were appropriate;
- Whether the lump sums available under the ex gratia scheme were appropriate, when considered along with the full range of benefits and compensation available under other Commonwealth or State statutory schemes;
- Whether the lump sums were consistent with the definitions of Tiers of participants; and
- Whether the lump sums were consistent with other one-off payments made to veteran groups.

When assessing the question of adequate remedies whether regard should be given to the establishment of a dedicated administrative assessment and settlement scheme, and If the lump sums available under the ex-gratia scheme are not considered to be financially adequate, discuss

what compensatory payment would be appropriate in light of the SHOAMP findings, other one-off payments made to veteran groups, and the full range of benefits and compensation available under other Commonwealth and State statutory schemes or common law damages available under Australian law.

The Inquiry will consider whether the overall handling and administration of ex gratia and compensation claims was appropriate, timely and transparent for both participants and their families. The Inquiry will consider whether, but not be limited to:

- Cross agency cooperation was effective;
- The documentation and records held by both Agencies as they relate to Deseal/Reseal activities was adequate;
- The standard of evidence required to substantiate a claim was reasonable and, if not, whether alternative standards of proof may be used when making an eligibility determination;
- There has been equitable treatment of service personnel, public servants, civilian employees and contractors involved in Deseal/Reseal activities;
- Staffing resources were adequate to produce a timely result;
- There were unreasonable delays in the process, taking into account the complex nature of issues; and
- The overall handling and administration of ex gratia and compensation claims was appropriate and timely.

The review will:

Examine the operation to date of the Military Rehabilitation and Compensation Act 2004

- Consider legislative and policy issues identified by stakeholders relating to the *Military Rehabilitation and Compensation Act 2004* (MRCA), including the quantum of benefits payable for death and serious injury.
- Document and examine past military compensation operational performance ideally from 1 July 2004 until 30 June 2009 and report on factors impacting on performance.
- Recommend possible legislative and policy changes relating to the MRCA and improvements to claims administration and service delivery.

Examine the legislative schemes that govern military compensation prior to the MRCA and identify any anomalies that exist

- Consider unintended differences identified between the MRCA and the *Safety, Rehabilitation and Compensation Act 1988* (SRCA), Defence Determination 2000/1, the *Military Compensation Act 1994* (MCA), and the *Veterans' Entitlements Act 1986* (VEA).
- Consider legislative and policy issues identified by stakeholders relating to transitional arrangements between the VEA/SRCA and the MRCA.
- Recommend possible changes to address unintended differences identified by stakeholders between the MRCA and the SRCA, Defence Determination 2000/1, the MCA, and the VEA and issues relating to transitional arrangements between the VEA/SRCA and the MRCA.

Examine the level of medical and financial care provided to Defence personnel injured during peacetime service

• Consider what level of financial and medical care is available to people with warlike and non-warlike service which is not available to people with peacetime service only.

- Estimate the extent of suicide in the ex-service community, compared to the general community; and
- Prepare a final report to the Minister of Veterans' Affairs by December 2008 with appropriate findings and recommendations.

Review of DVA—Funded ESO Advocacy And Welfare Services—Terms of teference

Content and approach

The Review of DVA-funded ESO Advocacy and Welfare Services (the Review) will be conducted by David Batchelor and Olivia Witkowski, with advice and support from other departmental officers and will include:

- 1. reviewing the following programs:
 - a. Building Excellence in Support and Training (BEST) Grants Program,
 - b. Training and Information Program, and
 - c. Veteran and Community Grants Program;
- 2. conducting the Review in consultation with the ex-service community and other relevant stakeholders;
- 3. examining current ESO service models in considering future funding models for their delivery of advocacy and welfare services to the veteran community in relation to VEA, SRCA and MRCA entitlements; and
- 4. identifying interdependencies and interactions of the three programs.

Objective

The objective of the Review is to recommend a program that ensures:

- funding levels enable efficient and effective service delivery;
- the range of items eligible for funding are distinct;
- appropriate services are provided for younger veterans;
- the distribution of available funds is transparent and fair;
- there is no duplication of ESO advocacy and welfare services funded by the Government in individual locations; and
- harmonious working relationships are established and maintained.

Key issues

The following points will also be addressed:

- consideration of the recent recommendations made by Professor Dunt as well as the Government's Election Commitment to establish a public register of ex-service officials and conduct regular surveys of them;
- the impact of rolling *Grants-in-Aid* into BEST in 2009/10;
- the sustainability and scalability of future programs;
- opportunities for ESOs to share resources and work in partnership;
- ensuring the concept of "volunteerism" remains a key theme;
- options and implications for change to funding cycles and length of grant funding periods; and

• the effectiveness and efficiency of DVA administrative arrangements, including grant monitoring and acquittal processes.

Key program redesign elements

The Review will consider previous BEST and GIA grant application processes and outcomes, and incorporate the following items for each recommended ongoing program:

- guidelines, operations and administration, including processes, quality assurance, performance measurement and accountability;
- technology and systems,
- eligibility and assessment criteria;
- client demographics;
- location of ESO, DVA and community support groups;
- items that are currently funded;
- the extent to which all programs are meeting the needs of the key stakeholder groups;
- other DVA programs and sources of support; and
- areas of concern from each of the key stakeholder groups.

In considering any new arrangements, the eligibility criteria and items to be funded under the V&CG Program will be taken into account.

Deliverables

The review team will provide a report with recommendations to the Secretary and the Minister. This will include recommendations for:

- renewed programs that provide appropriate financial support and training;
- sites that would serve as a centre-of-expertise for surrounding more "localised" services, including the nature and extent of technological and administrative needs to support ESO activities;
- streamlined but more rigorous grants application, assessment, contractual and monitoring/acquittal processes; and
- optimal grant allocation timings that is, frequency of grant Rounds in any given financial year and length of grant coverage (eg one, three, five years).

Timeframe

The Review will commence by end August and will be concluded by mid-December 2009.

Governance

The Review Team will be guided by the National Manager Research, Development and Support on a day-to-day basis. Senior direction will be provided by the Repatriation Commissioner and the General Manager Support Division.

Interdependencies

The Review Team's analysis will inform the separate consideration being given to the conditions under which the funds remaining from Round 11 will be made available to ESOs within the 2009/10 financial year. The Review Team's input will be important to the Department making recommendations to the Minister that are not inconsistent with either:

- the decision-making framework applied to Round 11 to date or
- the objectives of the Review.

Question 19

Program 1.2 Topic: Compensation—£20 Million lump sum Hansard, page 97

Senator XENOPHON asked:

So you are not aware of any consideration of some of the 20 million lump sum being used for compensation.

Mr Campbell—No.

Senator XENOPHON—Are you able to take on notice whether that was ever considered by the department back in the early 1990's. I appreciate that might not be within your knowledge.

Mr Campbell—I would always accept a question on notice, but I suspect that the answer will be that we do not know. But I will take it on notice. **Answer**

Answer

The Department of Resources, Energy and Tourism has advised that the UK Government's £20 million payment was made in response to the then Australian Government's representations for a substantial contribution to the over \$100 million cost of rehabilitating the nuclear test sites. This claim followed the recommendation of the Royal Commission into British Nuclear Tests. The Royal Commission recommended a full clean-up of the test sites with the United Kingdom to cover the costs. The payment, in its entirety, was intended for, and committed to, the Maralinga site clean up. The then Department of Resources and Energy had prime responsibility for this matter in the early 1990s. No part of this payment was directed to the Department of Veterans' Affairs.

Specific questions about this arrangement should be directed to the Department of Resources, Energy and Tourism.

Question 20

Program 1.2 Topic: UK Class Action, lump sum compensation Hansard, page 97

Senator XENOPHON asked:

I have been told that Australian veterans that were at the British atomic tests currently only have one avenue of seeking compensation in terms of lump sum compensation, and that is to join a UK class action against the British Ministry of Defence. I think that their time limit for doing this is May and that there is currently an appeal before the High Court about an extension of time issue. Is your department aware of that particular case in the UK—the class action on behalf of British veterans that Australians may be able to join? Is there any proposal by the department of the government to give veterans support to assist with this?

Mr Campbell — Yes, I am aware of the court action that is proceeding in the UK. I am not in any way across the fine grain of detail of it and, no, I am not aware of any proposal for consideration of giving financial assistance.

Senator XENOPHON — Perhaps I could ask Senator Stephens to put on notice whether the minister has considered any requests for assistance or is considering providing assistance to veterans to join the action.

Senator STEPHENS — I am happy to take the question on notice.

Answer

It is not correct to say that the only avenue for Australian participants to access compensation is through a class action against the UK Government. Australian British Nuclear Test participants, including ex-defence force members, civilians and other Commonwealth employees all have access to statutory compensation, either under the *Safety, Rehabilitation and Compensation Act 1988* (SRCA) or the civilian SRCA-like administrative scheme, as relevant, to claim compensation

for conditions that they consider were caused by exposure to ionising radiation. In addition, all Australian British Nuclear Test participants have access to a non-liability health care scheme administered by the Department of Veterans' Affairs which covers the cost of testing and treatment for all cancers, irrespective of cause.

The responsibility for common law claims relating to the British Nuclear Tests rests with the Department of Resources, Energy and Tourism. There is no proposal by the Department of Veterans' Affairs to support, financially or otherwise, the Australians seeking to join the UK class action. The Department and the Minister for Veterans' Affairs neither encourages nor discourages participants from undertaking legal action.

Question 21

Program 1.2 Topic: Compensation Schemes Hansard, pages 97 and 98)

Senator XENOPHON asked:

Finally, both to the government and to Mr Campbell: my understanding is that there are statutory compensation schemes in terms of lump sum compensation for veterans of atomic tests in France and the United States. Whether you were upwind or downwind, the compensation, in addition to medical benefits is \$50,000 and \$75,000. In Russia and even in China there is compensation. Are you aware of the framework of any of those schemes, particularly in the United States and France? Was any consideration given to the operation of those schemes in an Australian context? Again, you may wish to take that on notice.

Mr Campbell — I will take it on notice, but I would make two observations. One is that, if compensation does flow, there has to be a link between the event and the outcome. Secondly, I think it is very difficult to pull out one example of how a country operates all its compensation systems. That said, we will take that on notice.

Senator XENOPHON — On notice, could you provide me with some more information in relation to that?

Mr Campbell — We certainly will provide you with briefing notes on the health studies that have been done and the effects, because the point I have been making about exposure and extent of exposure is quite important.

Answer

Answers to questions on notice from Department of Veterans' Affairs

Part 1–Overseas Compensation Available to Nuclear Test Participants

Background

The Department is aware of compensation schemes of other countries for their nuclear test participants.

Caution must be exercised in comparing schemes between countries given that the schemes have been developed in the unique social, historical, economic, health and legislative contexts of each country. Furthermore, the eligibility rules of each scheme, for example liability requirements, onus and standards of proof, conditions covered and definitions of participants, differ significantly between various schemes.

<u>France</u>

France has recently passed legislation to enable statutory compensation to military and civilian personnel who have suffered radiation related illnesses, as identified by the United Nations Scientific Committee on the Effects of Atomic Radiation (UNSCEAR) as a result of the French nuclear tests conducted between 1960 and 1996. Information available to the Department indicates that claims are to be determined on a case by case basis by a committee. A total amount of compensation has been earmarked, although how this will be apportioned amongst claimants is not totally clear.

United States of America

The US Department of Veterans' Affairs provides compensation on a presumptive basis for a statutory list of cancers to 'radiation exposed veterans' or their survivors, who participated in nuclear tests by the U.S. or its allies, who served with the U.S. occupation forces in Hiroshima or Nagasaki, Japan, between August 1945 and July 1946, or who were exposed to ionising radiation while a prisoner of war in Japan, provided the condition manifests within certain time periods. In addition to the presumptive conditions, a claim for compensation may be made under a statutory scheme on the basis of proving causation of conditions and exposure to radiation.

Compensation is also payable through the US Department of Justice under the 1990 Radiation Exposure Compensation Act (RECA) to individuals who have developed lung or kidney diseases or one of 19 types of cancer, and were living in areas of Nevada, Arizona or Utah downwind of nuclear test sites (eligible for a \$50,000 payment) or were on-site nuclear test participants (eligible for a \$75,000 payment). The statutory criteria do not require claimants to establish causation. Rather, a claimant qualifies for an award by establishing the diagnosis of a listed compensable disease after working or residing in a designated location for a specific period of time.

China and Russia

Comprehensive details of the various benefits available to nuclear test participants in countries such as Russia and China are not available and have been sourced from unsubstantiated information.

However, the little evidence available on benefits provided to Russian nuclear test participants indicates that the Russian Government passed a series of decrees in 2004 to provide healthcare and a small monthly payment to test participants, however there is no blanket compensation scheme.

Further reports claim that the government of Kazakhstan, home to the former Soviet test site of Semipalatinsk, has been paying compensation to the local population there whilst another report indicates that compensation was only offered to veterans who were part of the Totsk test, however, civilians affected by the tests were excluded.

There is little evidence available regarding compensation or health care provided by China, however, media reports indicate that, in 2008, China began making payments or 'subsidies' to personnel involved in nuclear tests as part of its effort to improve benefits for former military veterans. It is unclear what prompted China's decision to make these payments or whether the payments cover medical costs for civilian residents and military personnel possibly affected by the tests.

<u>Australia</u>

Australia provides statutory and administrative schemes of compensation for conditions accepted as caused by ionising radiation for former Australian Defence Force members (ADF), other Commonwealth employees and civilians involved the British Nuclear Test (BNT) program in Australia. Australia also provides a non-liability (i.e. presumptive) health care scheme for all Australian British Nuclear Test participants that covers the cost of all testing and treatment for cancers irrespective of cause. This health care scheme does not require proof of exposure to ionising radiation but a person must meet the definition of a participant.

The non-liability health care scheme was a direct result of the Government's commitment to respond positively to the results of the 2006 Australian Participants in British Nuclear Tests in Australia Mortaility and Cancer Incidence and Dosimetry Studies, which are summarised below.

On 11 May 2010 the Minister announced that the Government had accepted the Clarke recommendation to provide Defence Force personnel who participated in the BNT program with access to compensation under the *Veterans' Entitlements Act 1986* (VEA) for any conditions related to their BNT service. Defence Force members who participated in the BNT program will be eligible to claim for the disability pension and health care. Their partners may also be eligible to claim war widow/widower's pension.

Access to these VEA benefits will be available from July 2010, subject to the passage of legislative change.

Part 2–Briefing notes on Australian participants in British Nuclear Tests in Australia 2006 Studies

<u>Background</u>

• In July 1999, the then Minister for Veterans' Affairs, the Hon Bruce Scott MP, announced that a study of Australian participants in the British nuclear tests program conducted in Australia between 1952 and 1963 would be undertaken.

- The *Mortality and Cancer Incidence Study* was undertaken by Adelaide University Department of Public Health. The *Dosimetry Study* was undertaken by the Dosimetry Sub-Committee and Exposure Panel consisting of radiation safety consultants, academics and members of the Australian Radiation Protection and Nuclear Safety Agency (ARPANSA).
- The studies were overseen by an independent Scientific Advisory Committee and a Consultative Forum of ex-service representatives and representatives from DVA, the Department of Defence, COMCARE and the Department of Industry, Science and Resources.
- The studies were completed in June 2006. The bulk of the seven years needed to complete the study was occupied by extensive archival work to compile a study roll of participants and to gather all available documents as to details of the conditions at the test sites.
- The total cost of the studies was estimated to be approximately \$2 million.
- The reports of both studies can be accessed online on the Department's website at http://www.dva.gov.au/health_and_wellbeing/research/Pages/health%20studies.aspx#nuctest.

Australian Mortality and Cancer Incidence Study 2006

- The *Mortality and Cancer Incidence Study* deals with the rates of mortality and cancer incidence amongst British nuclear test participants. The *Mortality Study* compared the number of deaths in test participants with the general population from the time of the tests to 2001; the *Cancer Incidence Study* compared the number of cases of cancer in test participants with that in the general population from 1982 to 2001.
- The study found that the overall death rate for nuclear test participants was similar to that of the general population.
- However, there was an increase in the rate of cancer (23 per cent) and cancer-related deaths (18 per cent) compared to the general population. In layman's terms, this increase equates to five more cancer deaths per year among nuclear test participants, compared to the general population.
- Cancer of the lip, oral cavity and pharynx (41 per cent), oesophageal cancer (48 per cent), colorectal cancer (16 per cent), lung cancer (28 per cent), melanoma (40 per cent), prostate cancer (22 per cent), leukaemia (43 per cent) and radiogenic cancers (a combined group made up of thyroid, stomach, colon, liver, lung, bladder, non-CLL leukaemia and non-melanoma skin cancer 19 per cent), were significantly elevated compared to the general population. Other cancers observed were not significantly different to those expected within the general population.
- Although the overall incidence of cancer amongst the test participants was higher than expected, no correlation was found between cancer incidence and estimated radiation dose.
- In September 2008, the findings of the *Mortality and Cancer Incidence Study* were published in an international peer reviewed journal, *Occupational and Environmental Medicine*.

Dosimetry Study 2006

- The *Dosimetry Study* attempted to reconstruct the dose of radiation received by the nuclear test participants, based on established principles of nuclear physics and job descriptions extracted from a range of source documents.
- As part of the study, the radiation exposures of 10,983 participants were estimated. Both internal and external exposure pathways were considered.
- The report concluded that 79 per cent of the participants received a dose of radiation equivalent to the recommended annual dose limit for members of the Australian public. Only four per cent of test participants were estimated to have received doses greater than the internationally recommended annual limit for radiation exposure workers.
- While particular individuals may have been exposed to radiation levels higher than the group estimations, the study was concerned with average group levels of exposure.
- No association was found between the number of cancers observed amongst test participants and their estimated dose of radiation.
- The *Dosimetry Study* was previously internationally peer reviewed by three experts at the request of the Department and was considered to be sound.
- In September 2009, a summary of the findings of the *Dosimetry Study* was published in an international peer reviewed journal, *Radiation Protection Dosimetry*.

Government response

- Despite having found no association between cancer incidence and estimated radiation exposure, the Government in 2006 introduced a scheme to provide test participants with non-liability health care testing and treatment (White Card) for all cancers.
- Eligible participants under the *Australian Participants in British Nuclear Tests (Treatment) Act 2006* are entitled to non-liability testing and treatment of any malignant cancer. This coverage is open to any member of the ADF, Commonwealth employees, Commonwealth contractor or member of the Commonwealth Police, Australian Federal Police or Australian Protective Services who satisfies the definition of an Australian participant in the British nuclear tests.
- On 11 May 2010 the Minister announced that the Government had accepted the Clarke recommendation to provide Defence Force personnel who participated in the BNT program with access to compensation under the *Veterans' Entitlements Act 1986* (VEA) for any conditions related to their BNT service. Defence Force members who participated in the BNT program will be eligible to claim for the disability pension and health care. Their partners may also be eligible to claim war widow/widower's pension.
- Access to these VEA benefits will be available from July 2010, subject to the passage of legislative change.

Question 22

Program 1.2 Topic: Indexation for Military Superannuation Pension Written question

Senator XENOPHON asked:

- a) The recent Matthews review into pensions in Australia recommended that the CPI remain the basis of indexation for military superannuation pensions, even though this means that military pensions are indexed at a lower rate than the aged pension, disadvantaging exservicemen and women. What is the DVA's position on this recommendation?
- b) Given that the CPI is no longer considered accurate for indexing other pension schemes, can the DVA explain why military superannuation pensions are still using this method?

Answer

a) and b)

These are matters of Government policy. The Department of Veterans' Affairs has no position on these issues. In any event under the Administrative Arrangement Orders they are matters for the Departments of Defence and Finance and Deregulation to consider.

Question 23

Program 1.1 Topic: Veterans' Income Support and Allowances–Pension Rate Disparity Written question

Senator KROGER asked:

- a) How many veterans paid a disability pension did not receive indexation received by other disability pensions? What type of pension do these pensioners receive?
- b) On what basis were these pensioners denied an increase?

Answer

a) and b)

All DVA pensions are indexed in March and September of every year, as are Centrelink payments.

DVA pensions are indexed by factors that measure the increase in the Consumer Price Index, or the Pensioners & Beneficiary Living Cost Index and are benchmarked to a percentage of male weekly wages.

It is important to note the distinction between DVA Disability Pension and Disability Support Pension paid by Centrelink.

Disability Pension paid by DVA is a compensation payment for war or service related injury or disease. It is not an income support payment, is not income or assets tested and is not taxable income.

In contrast, Disability Support Pension paid by Centrelink is an income support payment paid to those who are unable to work because of disability. It is paid at the same rate and is subject to the same income and assets test as the Age Pension and the Service Pension.

A person with a DVA Disability Pension who meets the income and assets tests may also be entitled to be paid either a Service Pension from DVA or a Disability Support Pension or Age Pension by Centrelink.

As at January 2010, 5,456 T&PI pensioners did not receive any income support payment from DVA or Centrelink. There are 1,843 single T&PI pensioners who receive a part Service Pension, part Age Pension or part Disability Support Pension. Another 7,742 partnered T&PI pensioners receive a part Service Pension, part Age Pension or part Disability Support Pension. The maximum rate Service Pension, maximum rate Age Pension or maximum rate Disability Support Pension is paid to 5,212 single T&PI pensioners and 9,246 partnered T&PI pensioners.

The Secure and Sustainable pension reforms addressed the adequacy of the Australian income support system. It therefore did not examine the DVA Disability Pension.

The cost to pass on the same level of increase as was made to the single Service Pension to DVA Disability Pensions would be \$587.3 million over 4 years. Those DVA Disability Pensioners who receive a single rate income support payment have already received the increase.

Question 24

Program 1.1 Topic: Veterans' Income Support and Allowances – Pension Rate Disparity Written question

Senator KROGER asked:

Other disability pensioners received an increase, but not some of our T&PI community. I understand these increases were made to compensate for a rising cost of living. How much would it cost to give all those who missed out the same pension increase in line with what they were verbally promised?

Answer

Answer

Senator KROGER asked:

- a) Would the Department outline the compensation arrangements which apply to all DVA clients under the Carbon Pollution Reduction Scheme?
- b) Can the Department guarantee pensioners that they will not be worse off under the scheme?
- c) Will DVA pensioners be absolutely, totally compensated for any increase in the cost of living?
- d) Can the Department guarantee that no veteran will be worse off under the Government's Carbon Pollution Reduction Scheme?
- e) Electricity prices may rise by up to 60 per cent under the ETS, will electricity price rises be fully compensated under the ETS?

Question 28

Program 1.2 Topic: Rehabilitation Compensation Acts Payment–Income Support and Compensation Written question

Senator KROGER asked:

- a) How much would it cost to change the classification of the service of nuclear testing veterans to "non-warlike hazardous" as recommended by the Clarke Review?
- b) What impact would this change have for entitlements to the Gold Card and what is the component of the Gold Card cost of reclassification of service?

Answer

- a) The total cost of implementing the effect of the Clarke recommendation is estimated at \$24.2 million over four years.
- b) Included in this figure is an estimated Gold Card cost of \$17.4 million which would be offset by existing white card costs and costs relating to the Medicare Benefits Scheme and Pharmaceutical Benefits Scheme.

Question 29

Program 1.2 Topic: Rehabilitation Compensation Acts Payment–Income Support and Compensation Written question

Senator KROGER asked:

Has the Department ever had any involvement with Professor Bruce Armstrong?

- a) Has Professor Armstrong had any involvement in further analysis of the Cancer and Mortality Study conducted for nuclear testing victims?
- b) What is that involvement?
- c) Has the Minister ever requested contact with Professor Armstrong through the Department? If so, when?

Answer

Professor Bruce Armstrong was the Chair of the Scientific Advisory Committee (SAC) for the 2006 studies of Australian participants in the British nuclear tests in Australia *Dosimetry* and *Mortality and Cancer Incidence*. The SAC had the role of reviewing and advising on the methodology of the studies and supervised the reports' preparation.

a) and b)

Since the conclusion of the studies, Professor Bruce Armstrong has not been involved in further analysis of the *Mortality and Cancer Incidence* study.

c) On 22 July 2008 Minister Griffin met with Professor Armstrong to discuss the 2006 studies.

Question 30

Outcome 2: Health Topic: Health e-Health and "health identifiers" Written question

Senator KROGER asked:

- a) Will the Department guarantee privacy of records held by DVA during the roll out of Health Identifier numbers? What safeguards are being put in place to ensure this?
- b) Will the Department further guarantee that this number will in no way replace existing DVA numbers?

Answers

a) The Health Identifiers (HI) Service will be managed by Medicare Australia (the service operator) and will provide the same level of protection to veterans' and war widows' personal information as required by the HI legislation.

DVA will only disclose to the service operator 'identifying information', as defined under the *Health Identifiers Bill 2010* (i.e., the DVA file number, name, date of birth, sex, address of healthcare recipients), in order for the service operator to correctly identify an individual and to assign a unique Individual Health Identifier (IHI). The service operator will not have access to an individual's personal information other than the indentifying information provided for assignment of an IHI. This arrangement ensures that personal information of DVA clients is protected from unauthorised access.

The implementation of the IHI will have no bearing on the individual records currently managed by DVA. Personal information, including health information, is protected by the *Privacy Act 1988* and disclosure is limited to the circumstances authorised under that Act.

b) The DVA File Number identifies DVA beneficiaries and, therefore, has a different purpose to that of the IHI. The Department can guarantee that the IHI will not replace existing DVA File Numbers, which will continue to be the means of identifying veterans and war widows with DVA entitlements.

Question 31

Program 2.2 Topic: Veterans' Hospital Services – Cost of healthcare and the ETS Written question

Senator KROGER asked:

a) In answers to questions from the last Estimates, DVA indicated that DVA "negotiates annual indexation adjustments with each state and territory". Will the next round of adjustments take into consideration the potential cost increase of the ETS?

b) Has the Department undertaken any modelling into what the cost of the ETS may be on all services provided by the Department? What will this cost be? How will the Department offset these costs?

Answer

- a) The Government has announced that it will not introduce the Carbon Pollution Reduction Scheme (CPRS) until after the end of the current commitment period of the Kyoto Protocol and only when there is greater clarity on the actions of other major economies including the US, China and India. This means the Government will not move to legislate the CPRS before the end of 2012.

This means the Government will not move to legislate the CPRS before the end of 2012.

Question 33

Program 2.5 Topic: Veterans' Counselling and other Health Services (Outcome 2) Written question

Senator KROGER asked:

- a) We have seen much in the media recently about mental health concerns amongst the younger veteran community, particularly out of Iraq, Afghanistan and Timor. What is the Department doing to engage with these younger veterans?
- b) How much is it spending on counselling for younger veterans?
- c) Does the department make counselling available for parents of younger veterans who do not have partners?
- d) Are parents and other siblings encouraged to contact VVCS if they are concerned about a family member recently returned from duty? Could this be investigated?

Answer

- a) VVCS has an Agreement for Services with the Department of Defence to provide counselling services and group programs to ADF personnel who are referred by Defence Medical Officers. VVCS employs an ADF Liaison Officer whose responsibility is to build linkages between ADF and VVCS to facilitate early intervention with younger veterans. This includes:
 - VVCS counselling and group programs are available to all younger veterans and their partners and dependant children
 - VVCS provides the Stepping Out Program to Defence personnel, and their partners, in the process of transitioning from Defence. The Stepping Out Program is advertised several times a year in Defence Family Matters and all three Service Newspapers.
 - VVCS staff attend each Defence Transition Seminar to deliver a standard presentation on services available including the Stepping Out Program. They also disseminate brochures, fact sheets and information about how to contact VVCS.
 - VVCS has presented at Defence Reintegration Briefing seminars in Darwin, Townsville and Brisbane for ADF members returning from Afghanistan.
 - VVCS centres have developed strong relationships with Defence Area Health Services, Psychology Corps and Chaplaincy in all regions. VVCS responds to invitations to attend Defence service information presentations including DCO Family Fun days, and Defence health Expos.
 - Veterans Line, the after hours telephone crisis counselling service is available to all younger veterans and their partners. The Defence All hours Support Line is a 24-hour mental health support and triage telephone service available to all

Defence personnel, which where appropriate, refers or recommends younger veterans and their family members to VVCS. VVCS can offer after-hours face to face counselling by appointment.

- VVCS has participated in the Transition Mental Health and Family Collaborative pilot in Townsville in 2009, with the aim of enhancing collaborative service provision to all medically discharging members and their families.
- b) Total cost to the Department for the provision of counselling services for younger veterans during 2009 totalled \$3.028 million
- c) VVCS responds to enquiries from parents of younger veterans by offering a limited number of sessions of counselling followed by referral to more appropriate service providers. With the member's permission, parents are invited be involved in planning treatment for the younger veteran.
- At Defence Decompression/Reintegration Seminars VVCS provides information on potential adjustment issues that may arise for the veteran and their family upon return to Australia. Family members are invited to contact VVCS if they have concerns about the returned veteran.

Question 34

Program 2.5 Topic: Veterans' Counselling and other Health Services Written question

Senator KROGER asked:

Can the department outline costs for DCO and VVCS counselling services? Particularly, can the Department please provide:

- a) Numbers of contacts from veterans of recent conflicts?
- b) Amount spent on 'reach out' programmes to younger veterans (i.e. through stepping out)

Answer

a) The Defence Community Organisation (DCO) operates within the Department of Defence portfolio, therefore, we are unable to provide information about their counselling services.

In VVCS the term 'contact' has a specific meaning, that is, any person who contacts VVCS to seek services prior to establishing if they are eligible to receive a service. During 2009 VVCS centres provided intake services to 2,122 veterans of recent conflicts. VVCS subsequently provided 9,853 counselling sessions to 1,358 veterans from recent conflicts. In addition, 455 current serving members received 2,916 counselling sessions through the Fee for Service Agreement with the Department of Defence. After hours the Veterans Line

service delivered an additional 693 telephone counselling session to veterans of recent conflicts.

As many veterans of recent conflicts (Iraq, Afghanistan and Timor) have been engaged in multiple deployments VVCS uses age ranges to report service usage activity rather than by conflict zone.

b) VVCS provides a range of mental health group programmes that are available to all veterans including Younger Veterans. The Stepping Out Program was developed specifically to assist younger veterans in their transition from the ADF to civilian life and provide a pathway to improve access to VVCS services in the future. Total expenditure for the Stepping Out Program for the financial year 2008-2009 was \$106,597.95 and to date is \$69,521.35 for the current financial year.

Question 35

Program 2.5 Topic: Veterans' Counselling and other Health Services Written question

Senator KROGER asked:

- a) What current programmes are operating on-base to assist servicemen and their families in transition?
- b) What interaction does VVCS have with on-base services?

Answer

a) **On-Base presence**

DVA currently has staff working full-time at Lavarak Barracks (Townsville) and Enoggera Barracks (Brisbane). These staff provide both Transition Management Service and general claims advice. They also interact with the Defence Transition cell and the Australian Defence Force (ADF) Rehabilitation programme to facilitate a seamless process during transition. A visiting service is provided to other bases around the country. The visits are scheduled according to need.

Transition Management Service (TMS)

A TMS is currently available to assist ADF members with transition from military service to civilian life. This service is provided by DVA under a Memorandum of Understanding (MOU) with Department of Defence to support members being discharged on invalidity grounds. Defence have advised they will be taking responsibility for TMS service and will not be requiring this service from DVA after 30 June 2010.

Additional estimates 2009–10; 10 February 2010 Answers to questions on notice from Department of Veterans' Affairs

ADF members who are in the process of being discharged on invalidity grounds are offered advice and support through this optional service. The support provided by the TMS to members discharging on invalidity grounds includes assistance with:

- civilian employment options;
- compensation;
- superannuation;
- financial planning;
- transition adjustment issues; and
- health insurance and community support arrangements.

Group Presentations delivered by DVA:

- Transition Seminars
- Pre-deployment seminars
- Post deployment seminars
- Induction seminars
- Recruit courses
- Presentations to units at the request of the CO

Regional Stakeholder Forums

An initiative associated with IPSS involving regular meetings between Defence and DVA stakeholders.

Services provided by Defence

Defence also has programs operating on base to assist transitioning members. Details of these programs would be available from Defence.

b) VVCS attends Regional Mental Health Team meetings, and has relationships with ADF Area Health Services, Psychology Corps, Chaplaincy, ADF Rehabilitation Program Coordinators and Defence Transition Support Services on Defence bases. VVCS responds to invitations to deliver information about VVCS services to Defence service information forums including Defence Communities Organisation Family Fun days, and Defence Health Expos.

Question 36

Program 2.5 Topic: Veterans' Counselling and other Health Services Written question

Senator KROGER asked:

- a) Have these matters been considered by the Review of Military Rehabilitation which is currently underway?
- b) On this topic, has the Minister received a request to extend the time for the review beyond 31 March 2010?

c) Until what date has the request been made?

Answer

- a) Services provided by Defence Communities Organisation and VVCS to younger veterans and their families are not within the Terms of Reference for the Review. The Review is considering the operation of the MRCA including rehabilitation and medical treatment provided to younger veterans, a compassionate payment scheme for families of Australian Defence Force members, and the level of medical support provided to members with peacetime service only.
- b) The Review has many significant and complex issues under consideration. The Minister and Steering Committee have, therefore, agreed that the Review will continue beyond 31 March 2010.
- c) No fixed date has been set for delivery of the Report.

Question 37

Outcome 1 and 3, programs 1.4, 3.1 and 3.2 Topic: Grants Written question

Senator BARNETT asked:

These are subject to a continuing order of the Senate. Examine what has been provided and ask about non-answers, or potentially controversial grants.

Has the Department complied with interim requirements relating to the publication of discretionary grants?

Answer

The Department administers four Grants Programs:

- 1. Building Excellence in Support and Training (BEST);
- 2. Veteran and Community Grants (V&C);
- 3. Saluting their Service (STS); and
- 4. Overseas Memorial Restoration Grants.

The Commonwealth Grant Guidelines were formally published in July 2009 including the requirement that all grants are to be published on the departmental website within seven (7) days of signing the grant agreement.

The Department was compliant with regard to the Veteran and Community Grants, *Saluting Their Service* and Overseas Memorial Restoration Grants. However, the Department was not compliant with regard to all 2009-10 BEST Grants.

In previous funding rounds the Department has waited until all BEST grant agreements have been signed and returned before publishing the entire list on the website. Unfortunately, because there were 282 grant applications in 2009-10, waiting until all grants documentation had been returned meant that the Department missed the seven-day deadline. Having realised that this approach will not enable future compliance, the Department now publishes the details of each grant as the relevant documentation is finalised.

Question 38

Outcome 1 and 3, programs 1.4, 3.1 and 3.2 Topic: Discretionary grants Written question

Senator TROOD asked:

Could the Department provide a list of all discretionary grants, including ad hoc and one-off grants since November 2007? Please provide details of the recipients, the intended use of the grants and what locations have benefited from the grants.

Question 40

Program 3.1 Topic: Commemorations AHS Centaur Written question

Senator KROGER asked:

What is the division of responsibilities on this issue between the Commonwealth and the Queensland governments?

Answer

Commonwealth responsibility for the protection of the wreck lies with the Department of the Environment, Water, Heritage and the Arts. The Department of Defence would have an interest in the ship because of its service as a hospital ship and because of military casualties within the wreck.

The Queensland Government's interest would relate to the location of the wreck within State waters and their support of the search for the *Centaur*.

Question 41

Program 3.1 Topic: Commemorations AHS Centaur Written question

Senator KROGER asked:

The site has been declared an Historical Shipwreck by the Environment Minister, what is being done towards the site's listing as a war grave?

Answer

The term 'war grave' is descriptive and confers no legal right or title.

Wartime shipwreck sites are often described as war graves. However, for the Commonwealth War Graves Commission (CWGC), which is responsible for commemoration of Commonwealth war dead of the two world wars, the term 'war grave' has a specific meaning and cannot be used other than for the official commemoration by interment of remains of our war dead in an established grave with a regulation headstone.

The CWGC commemorates those lost on the *Centaur* on the Sydney Memorial to the Missing within the CWGC Sydney War Cemetery.

In Australian waters, the Department of Environment, Water, Heritage and the Arts is responsible for ensuring protection of vessels such as the *Centaur* through the declaration of protected zones under the *Historic Shipwrecks Act 1976*.

Question 42

Program 3.1 Topic: Commemorations AHS Centaur Written question

Senator KROGER asked:

Can the Department please confirm the penalties applicable for interference with a war grave?

Answer

There is no specific Commonwealth legislation in respect to deliberately interfering with or damaging an official war grave. Individuals prosecuted for such offences would be dealt with under the appropriate State or Territory laws.

Question 43

Program 3.1 Topic: Montevideo Maru Written question

Senator KROGER asked:

- a) Is the Department engaged with Montevideo Maru Memorial Committee?
- b) How often has the Department met with the committee?

Answer

- a) Yes.
- b) The Department has been representated at two meetings between the Minister and members of the *Montevideo Maru* Memorial Committee. The Office of Australian War Graves (OAWG) has been requested by the Minister to investigate possible measures that could be used to protect the wreck, if and when it is located, from interference because of the casualties it contains. Program 3.1 Topic: Montevideo Maru Written question

Senator KROGER asked:

The Minister's last press release on the issue was 1 July 2009. Have there been any developments since then?

Answer

Subsequent to the Press release of 1 July 2009, the \$7,200 grant to the RSL Angeles City Sub-Branch in the Philippines resulted in a plaque being added to the Hellships Memorial at Subic Bay and additional information panels regarding the story of the Hellships at the local museum.

The plaque to the Montevideo Maru and the Rakuyo Maru was unveiled at the 2009 Remembrance Day ceremony held at the Memorial.

Question 45

Program 3.1 Topic: Montevideo Maru Written question

Senator KROGER asked:

Is the Government progressing towards a memorial to the ship here in Australia? If so, where?

Answer

Discussions about the construction of a memorial to commemorate those lost on the *Montevideo Maru* have taken place between the Minister for Veterans' Affairs and Mr Keith Jackson AM, Chairman, *Montevideo Maru* Memorial Committee. The option of constructing a memorial within the grounds of the Australian War Memorial has been discussed.

The Trust aims to raise money through corporate sponsorship, Government assistance and private funding.

The Department is currently assessing the details provided by the Trust and a brief with recommendations will be prepared for the Minister when the final assessment of the request has been completed.

Question 46

Australian War Memorial

Topic: Corporate sponsorship Written question

Senator KROGER asked:

Regarding the issues of corporate sponsorship at the Memorial:

- a) Has the Council received requests to sponsor other events?
- b) Can the Council provide a full list of sponsored projects at the Memorial?

Answer

a) Other than the recently announced support of the 95th Gallipoli Anniversary touring VC exhibition by Mr Kerry Stokes and Channel 7, there have not been any new sponsorship arrangements finalised for events, displays or other activities at the Memorial.

As indicated by the Director at the Additional Estimates hearing, the Memorial has a number of "irons in the fire" with regard to sponsorship but nothing that can be confirmed at this stage.

b) Over the years, there have been a number of sponsors and donors to the Memorial. The current listing on the Memorial's Donor Board is available on page 144-145 of the Annual Report 2008-09.

Question 47 Australian War Memorial Topic: Construction Written question

Senator KROGER asked:

Other than the construction for the National Servicemen's Memorial and the new Last Post Café, what other construction works are taking place at the Memorial?

Answer

The redevelopment of the Eastern Precinct, including the construction of a new café and the National Service memorial is almost completed. There are no other construction works currently taking place at the Memorial.

Question 48 Australian War Memorial Topic: Capital projects Written question

Senator KROGER asked:

What outstanding capital projects are there at the Memorial?

Answer

The redevelopment of the Eastern Precinct, including the construction of a new café and the National Service memorial, is almost completed. Plans have been completed and work has commenced for the half life refurbishment of the Second World War galleries and the Hall of Valor. All these projects are funded from capital funds in accordance with a long term plan. The development and implementation of an Enterprise Content Management System is also continuing and is partly funded from capital funds.

Question 49 Australian War Memorial Topic: Anzac Day 2010 Written question

Senator KROGER asked:

How will the Memorial commemorate Anzac Day this year?

a) Are there plans for travelling exhibitions?

Answer

The Memorial will host the Dawn Service, in close cooperation with RSL ACT, and the later National Anzac Day Ceremony.

Anzac Day will begin with the Dawn Service at the Memorial, a long standing Australian tradition commemorating the dawn landing on Gallipoli in 1915. The ceremony commences at 5:30am and is concluded by 6:30am. The Memorial's Commemorative Area opens 15 minutes after the Service concludes, and remains open until 8.30 am. This gives the public the opportunity to view the Tri-Service Guard mounted at the Tomb of the Unknown Australian Soldier as well as giving them the chance to lay a poppy on either the Tomb or against a particular name on the Roll of Honour.

The National Anzac Day Ceremony commences at 10.15am and includes a march by veterans of wars and peacekeeping deployments. The ceremony finishes with a flyover of aircraft from the Australian Defence Force. The National Ceremony is normally attended by VIPs such as the Governor-General and the Prime Minister of Australia. The Memorial opens 15 minutes after the completion of the National Ceremony, and remains open until 5 pm. The closing ceremony this

year will include a speech by one of the Memorial's historians and will feature the dismount of the Tri-Service Guard and the playing of the Last Post, the One Minute Silence and the Rouse.

Based on past years, it is anticipated that 20,000—30,000 people will attend the Dawn Service and between 10,000 and 20,000 will attend the National Ceremony.

a) There are no plans for a travelling exhibition specifically related to Anzac Day. However, the very successful travelling exhibition program, which is funded by the Minister for Veterans' Affairs' Commemoration Program, will continue. Full details of the program are available on the Memorial's website – <u>www.awm.gov.au</u>.

Question 50

Australian War Memorial Topic: Gallipoli Centenary Written question

Senator KROGER asked:

Can the War Memorial please explain its preliminary preparations for the 100th anniversary of Gallipoli in 2015?

Answer

The Memorial is represented on the Inter-Departmental Working Party (IDWP) that has been chaired by DVA to develop a whole of government approach to the centenary of the Gallipoli.

Council has, some time ago, considered a range of options whereby the Anniversary might be commemorated by the Memorial, and it is expected these will be considered by the IDWP in due course.

Question 51

Australian War Memorial Topic: Fromelles ceremony Written question

Senator KROGER asked:

Will the Memorial hold a ceremony in Australia in conjunction with the Fromelles ceremony in July?

What does it have planned?

Answer

No, the Memorial does not have plans for a special ceremony in Australia in conjunction with the Fromelles ceremony in July.
