#### Question

#### Answer

The Australian Government is seeking an FTA with **China** which serves Australia's interests. The 18th round of negotiations was held in Canberra from 19-21 March 2012 and negotiations are ongoing.

**Australia-Gulf Cooperation Council (GCC)** negotiations are suspended while the GCC reviews its FTA policy. Australian Ministers have been pressing for the negotiations to resume.

At the inaugural Indonesia-Australia Annual Leaders' meeting on 20 November 2011, Prime Minister Gillard and President Yudhoyono committed to "commence negotiations on an Indonesia-Australia Comprehensive Economic Partnership Agreement (IA-CEPA) at the earliest opportunity." The IA-CEPA will build upon each country's commitments under the ASEAN-Australia-New Zealand FTA (AANZFTA), which entered into force for Indonesia on 10 January 2012. Pre-negotiation consultations have been held twice in Indonesia (December 2010 and April 2011) and once in Australia (March 2011).

Dr Emerson met Malaysia's Minister for International Trade and Industry, Mustapa Mohamed, at the most recent Malaysia-Australia Joint Trade Committee meeting in Kuala Lumpur (31 January 2012) to review progress in the Malaysia-Australia Free Trade Agreement (MAFTA) negotiations. The Ministers confirmed their commitment to conclude negotiations on MAFTA in March 2012. Officials will meet in late March to consider outstanding issues.

The fourth officials' Pacific Agreement on Closer Economic Relations (PACER) Plus negotiating session, to be held in Brisbane from 27 to 29 March 2012, will focus on rules of origin, customs procedures and labour mobility. A Non State Actor Dialogue on PACER Plus, scheduled to be held in Brisbane on 26 March 2012, is an opportunity for interested members of civil society (i.e., the Pacific business community and non-government organisations) to get an update on the negotiations and express their views to officials involved in the PACER Plus negotiations.

Trans-Pacific Partnership Agreement Leaders announced the broad outlines of the TPP Agreement last November. This includes a commitment to pursue a comprehensive, ambitious agreement which eliminates tariffs and other barriers to trade and investment. Australia held bilateral meetings in February 2012 with Japan, Canada and Mexico regarding their interest in TPP membership. The next round of negotiations will take place from 8-18 May 2012 in the United States.

The Australia-India Comprehensive Economic Agreement (CECA) negotiations were launched in May 2011 and to date there have been two negotiating rounds: the first round took place in New Delhi on 28-29 July 2011 and the second round was held in Canberra on 17-18 November 2011. A third round is provisionally scheduled to take place in late May 2012.

Although the **Doha Round** remains at a standstill, there were some encouraging signs from last December's WTO Ministerial meeting, attended by Dr Emerson. Fifty countries representing 70 percent of global GDP joined Australia in making a comprehensive pledge against protectionism. During 2012 we will seek to have others join this pledge. Also encouraging were indications of support from a broad range of countries for concepts Australia and some of our likeminded partners advanced to establish new pathways forward for the Round. These concepts include breaking the Round into more manageable parts, adopting trade liberalisation measures that can be agreed in the short term and finding new ways forward for more intractable issues. Progress in the Doha Round remains vital to assist the recovery of the world economy. It is equally important that we continue to champion the vital role of the WTO in providing a framework which safeguards international trade and helps to resolve trade disputes.

Australia's negotiations with **Korea** are well advanced and the Australian Government is working hard to conclude the negotiations as soon as possible. Australia is not engaged in bilateral FTA negotiations with the **EU**.

#### Question

Regarding the Australia-Korea FTA, what has been the impact of the KORUS FTA on Australia's export market to South Korea? When is an agreement likely to be reached? #### Answer

The Korea- United States FTA (KORUS) only entered into force on 15 March 2012. It is, therefore, too early to measure the impact of KORUS on Australian exports to South Korea. Australia's negotiations with Korea are well advanced and the Australian Government is working hard to conclude the negotiations as soon as possible.

In April 2011, during Prime Minister Gillard's visit to Korea, the Prime Minister and Korean President Lee announced they would strive to conclude the negotiations by the end of 2011. However, the divisive political debate in Korea over the ratification of KORUS slowed progress on the Australia-Korea negotiations and the 2011 year-end target date could not be met.

Korea's focus on completing the domestic processes required to bring KORUS into force, following the acrimonious domestic debate in Korea on ratification of the agreement, has continued to impact the progress of Australia's FTA negotiations with Korea. Despite this, the Government is committed to concluding negotiations as soon as possible. Trade Minister Emerson told the ABC Radio's "Rural" program on 9 March, "in terms of the delay, if that were in our hands there would be no delay. I can't say on behalf of the Korean Government the date of which we might be able to finalise this agreement. What I can say is that at my level and at the highest levels of our Government, we're working very hard to complete the negotiations for the deal with Korea."

### Question

#### **Answer**

The Korea-US FTA negotiations were originally concluded in April 2007 but did not enter into force. The FTA was subsequently renegotiated and a new deal (KORUS) signed in December 2010. The Agreement passed through the US Congress in October 2011 and passed through the Korean National Assembly on 22 November 2011. Following domestic implementation processes in both the United States and Korea, KORUS entered into force on 15 March 2012. It is expected that, under KORUS, the United States will gain a competitive advantage over some Australian agricultural exports in the Korean market as the Korean tariffs on US imports of agricultural products, particularly beef, begin to phase-down over 15 years. The Government is concerned about the potential for such a tariff differential to adversely affect our agricultural exports to Korea and is, therefore, striving to conclude negotiations with Korea as soon as possible to safeguard the commercial interests of Australian agricultural exporters.

A review of all facilities relating to the Leighton Group was conducted on 21 December 2010, in the month prior to issuing the performance bonds, and most recently on 4 January 2012 as part of the annual client review process. As part of this process EFIC uses a proprietary service that searches more than 650 data bases to identify information relating to money laundering and terrorism financing activity, but given the breadth of this service, it is capable of revealing other issues that may warrant further investigation, such as reports on bribery or corruption. EFIC's annual review focused on the results of the detailed analysis and did not specifically focus on the Leighton Group's published Code of Ethics.

The reports and supporting information are also published on the Finance web site.

- (i) Details for travel for the period 1 July to 31 October 2011 were provided in the response to Question on Notice 170. The following information is for travel for the period 1 November 2011 to 29 February 2012.
- (ii) There were no security costs incurred for departmental officers.
- (iii) Departmental officers are entitled to a travel allowance which covers food, beverages and incidentals. It is not possible to itemise separately the amounts spent on food, beverages, alcohol and incidentals for each staff member for each trip.

(A) The total expenditure by the department (including both bills paid and payable) on external legal services for the financial year to 29 February 2012 was \$2 096 887.

It is not possible to provide a breakdown of the total legal services expenditure according to each service and its cost. To do so would involve an unreasonable diversion of government resources.

(B) The total expenditure by the department on legal services from the Australian Government Solicitor for the financial year to 29 February 2012 was \$904 940 broken down as follows: (i) \$694 483 for commercial advice; (ii) \$79 289 for litigation and dispute resolution; and (iii) \$131 168 for general advice.

- (C) The total expenditure by the department on legal services from private firms in Australia for the financial year to 29 February 2012 was \$420 440 broken down as follows: (i) \$364 704 for commercial advice; (ii) \$14 407 for litigation and dispute resolution; and (iii) \$41 329 for general advice.
- (D) The figures provided above in relation to total expenditure by the department on legal services from the Australian Government Solicitor and private firms do not include the external legal services expenditure by posts overseas. DFAT provides each Minister and Parliamentary Secretary with ICT equipment to support the operation of their offices and the work of their staff. Office equipment includes: laptop/PC, Blackberry, mobile phone, iPad, and iPhone.

ICT equipment is also available for the personal residence of the Minister or Parliamentary Secretary. Personal residence equipment includes: laptop, ADSL (Internet) connection, PC, printer, and fax.

There is no 'standard' offering as such; rather the mix of ICT equipment provided is determined by the particular needs of each Minister or Parliamentary Secretary, their staff and office.

The total cost of providing ICT 'services' to Ministers and Parliamentary Secretaries includes both equipment and services such as voice and data (3G or ASDL) connections to utilise devices provided.

Printers and multi-function devices (print, copy, scan and fax) are generally shared resources.

He added that the internet could not be trusted. This is a commonly held view within the Iranian Government, as illustrated by the Supreme Leader's directive of 7 March 2012, ordering the establishment of the Supreme Council for Virtual Space with the goal of 'the complete and up-to-date supervision of cyber space both inside the country and globally'.

As the 'in-nation' web initiative is not yet implemented, DFAT is not in a position to assess its impact.

- (B) The Australian Government does not intend to become a party to the Convention on the Human Rights of Migrant Workers and their Families for the reasons noted in (A) above.

The Department is aware of two comprehensive reviews that have evaluated Australia's bilateral free tradé agreements, including the Australia-United States Free Trade Agreement (AUSFTA):

- 1. The Independent Review of Export Policies and Programs (the 'Mortimer Report') released on 22 September 2008, which concluded that the three FTAs it reviewed (AUSFTA, Singapore-Australia Free Trade Agreement and Thailand-Australia Free Trade Agreement) were of a "world class standard and provide a strong basis for further expansion of trade and investment in the future" (page 99 of the review).
- 2. The Productivity Commission's Research Report on Bilateral and Regional Trade Agreements (BRTA) released on 13 December 2010. The Productivity Commission's Findings and recommendations are set out at pages xxxiv to xxxix of the report.
- 3.
