

AGREEMENT

between

GOVERNMENT OF AUSTRALIA

**Represented by the Australian Agency for International Development
(AusAID)**

and

**UNITED NATIONS RELIEF AND WORKS AGENCY FOR PALESTINE
REFUGEES IN THE NEAR EAST (UNRWA)**

**Relating to Australia's Contribution towards
UNRWA's [program/regular budget]**

Contributions

1. The Government of Australia, (hereinafter referred to as "Australia") by and through the Australian Agency for International Development (hereinafter referred to as "AusAID") undertakes to make available to the United Nations Relief and Works Agency for Palestine Refugees in the Near East (hereinafter referred to as "UNRWA") an amount of [AUD] as Australia's contribution towards UNRWA's [program/regular budget].

Financial Procedures

2. This contribution will be directed to support the UNRWA program(s) specified below:

3. Australia shall transfer the contribution to UNRWA's bank account, within thirty (30) days of signing by UNRWA and AusAID of this Agreement. The funds will be fully utilised and administered by UNRWA in accordance with the provisions of this Agreement and UNRWA's own financial rules and regulations.

4. Australia's contribution shall be made in United States dollars, being the equivalent, on the date of transfer, of [AUD]. Payment of Australia's financial contribution to UNRWA's [program/regular budget] shall be made into UNRWA's USD account at:

5. Any identifiable interest earned by UNRWA on the contribution will be added to the contribution and used as part of the funding.

Reporting

6. UNRWA shall provide AusAID with a report of UNRWA's [program/regular budget], which incorporates Australia's contribution, on or before [date].

Recognition of Contribution

7. In accordance with its rules, regulations and procedures UNRWA will endeavour to maximise opportunities for identifying Australia's contribution.

Privileges and Immunities

8. Nothing contained in this Agreement shall be deemed a waiver, express or implied, by UNRWA of its privileges and immunities.

Counter Terrorism

9. Consistent with UN Security Council Resolutions relating to terrorism, including UNSC Resolution 1373 (2001) and 1267 (1999) and related resolutions, both AusAID and UNRWA are firmly committed to the international fight against terrorism, and in particular, against the financing of terrorism. It is the policy of AusAID to seek to ensure that none of its funds are used, directly or indirectly, to provide support to individuals or entities associated with terrorism. To those ends, UNRWA is committed to taking appropriate steps to ensure that funding provided by AusAID to support UNRWA is not used to provide assistance to, or otherwise support, terrorists or terrorist organizations, and will inform AusAID if, during the course of this Agreement, UNRWA determines that any such funds have been so used.

Additional Matters

10. Any matter not covered by this Agreement shall be dealt with by consultation between the parties and be resolved in a spirit of co-operation which exists between them.

11. Upon termination any unused portion of the contribution will be returned to AusAID or used by UNRWA as agreed to by AusAID in writing.

12. This Agreement shall enter into force upon signature and may be modified by agreement in writing between the parties.

13. This Agreement stipulates the terms and conditions of Australia's contribution and is not an international treaty.
