China has pledged to reduce its emissions per unit of GDP by 40 to 45 per cent by 2020 compared to 2005. It has domestic targets under its twelfth Five Year Plan (2011 to 2015) to reduce both its emissions per unit of GDP and its energy consumption per unit of GDP. According to China's National Development and Reform Commission, energy consumption per unit of GDP dropped by 19 per cent (just short of its 20 per cent reduction target) over the period 2006 to 2010 (the eleventh Five Year Plan).

He also said it was important President Yudhoyono honoured his commitment that all abuses by security forces in the Papua provinces be investigated and punished.

On 7 February 2012, Australian Embassy officials in Jakarta made representations to Indonesian Government officials concerning the cases of the five Papuans facing subversion charges for their role in the Third Papuan Congress. At that time, Australian officials noted that the international community saw these cases as a violation of the right to freedom of expression and would be watching the trial closely.

On 4 April, after the conviction of the five Papuans, Australian Embassy officials in Jakarta raised our concerns over the sentences with Indonesian Government officials. The Australian officials also underscored that imprisoning peaceful political activists damaged Indonesia's human rights credentials and undermined Indonesia's reputation as a regional leader on human rights.

While encouraging best practice, the Guidelines also acknowledge that there may be practical limitations on the ability of enterprises to effect change in the behaviour of their suppliers.

Australia further co-sponsored a resolution on Sri Lanka at the UN Human Rights Council, which requested the government of Sri Lanka to present an action plan detailing the steps it has taken and will take to implement the LLRC's constructive recommendations and address alleged violations of international law. The resolution was adopted on 22 March 2012.

The Sri Lankan government has not publicly released its draft LLRC implementation action plan, although local media have published alleged government documents on implementation. The Sri Lankan government has advised its intention to consult with the public and all parties in the governing coalition before finalising the plan.

Presidential Secretary Lalith Weeratunga is heading a government taskforce that will oversee the implementation of the LLRC recommendations. The taskforce has not yet publicly specified which recommendations will be implemented nor provided a precise timeframe for implementation.

What is the government's official position toward Iran in terms of its human rights record? What steps are you taking to engage with them on that front?

Answer

The Australian Government remains deeply troubled by Iran's human rights record.

The Government continues to express concerns to the Iranian Government, urging Iran to repeal the death penalty, protect and promote rights to freedom of assembly and expression (including political and media freedoms), and uphold the rights of religious and ethnic minorities.

Where constructive to do so, the Australian Government has engaged with Iranian authorities on specific cases of particular concern, including that of Pastor Youcef Nadarkhani who was sentenced to death for apostasy. This includes representations by the Australian Ambassador in Tehran, and representations by officials in Canberra.

In addition to representations made directly to the Government of Iran, Australia maintains a strong record of defending human rights multilaterally, including in the UN Human Rights Council. Since March 2010, Australia has delivered six statements to the UN Human Rights Council expressing our deep concern at the situation in Iran.

The Government will continue to monitor closely the human rights situation in Iran, including through the Australian Embassy in Tehran. The Government will continue to raise concerns directly with Iranian officials and in multilateral fora in a constructive and appropriate way that reflects Australia's fundamental belief in the universality of human rights.

Can the department actually advise us on the status of this pastor [Pastor Nadarkhani] himself – his personal circumstances?

Answer

According to publicly available information, Youcef Nadarkhani is a pastor of the Protestant Evangelical Church of Iran. Born a Muslim, Pastor Nadarkhani is believed to have converted to Christianity in his teens.

Pastor Nadarkhani was first imprisoned in December 2006 on charges of apostasy but was released two weeks later without charge.

In 2009 he was re-arrested on charges of protesting and in September 2010 was sentenced to death for apostasy by the Assize Court in Gilan province. In November 2010 the verdict for his September trial was delivered in writing indicating that he would be executed by hanging. In June 2011 the Supreme Court of Iran instructed the court in Rasht to re-examine some procedural flaws in the case.

The legal process to review Pastor Nadarkhani's case is ongoing and he remains in custody.

What action is the department taking (if any) in response to the two motions in the Senate – 3 November 2011 and 1 March 2012 both pertaining specifically to Iran and to human rights issues?

Answer

The Australian Government has made multiple representations to urge Iran to uphold the human rights of its citizens and to protect religious freedom. These representations have included specific reference, where constructive to do so, to the case of Pastor Youcef Nadarkhani.

Prior to the passing of the two Senate motions (3 November 2011 and 1 March 2012), the Government had already made representations in support of Pastor Nadarkhani to the Iranian authorities. On 20 October 2011, officials from the Department of Foreign Affairs and Trade (DFAT) raised a range of human rights issues, including the Nadarkhani case, with the Iranian Embassy in Canberra. On 24 October 2011 Australian Embassy officials in Tehran raised Pastor Nadarkhani's case with Iranian Ministry of Foreign Affairs officials.

On 12 March 2012 Australia's Permanent Representative to the United Nations in Geneva delivered Australia's statement on Iran to the UN Human Rights Council. The statement specifically urged the Iranian Government to review the case of Pastor Nadarkhani. The statement also expressed concern at Iran's use of the death penalty, suppression of freedom of assembly and treatment of ethnic and religious minorities, including Baha'is. The statement urged Iran to stay all executions, respect human rights of all detainees and ensure all trials are conducted fairly.

On 6 June 2012 the Australian Ambassador to Iran expressed Australia's concern at Iran's human rights record to Iranian Ministry of Foreign Affairs officials. The Ambassador made specific reference to the case of Pastor Nadarkhani.

On 25 June 2012 senior officials from the DFAT raised Iran's human rights record with a visiting Iranian official, including specific reference to the case of Pastor Nadarkhani.

The Australian Government continues to closely monitor the human rights situation in Iran, including through the Australian Embassy in Tehran, and will continue to raise concerns with Iranian officials and through multilateral channels in ways that do not harm the interests of the individuals concerned.

Answer

India is examining introducing a pilot emissions trading scheme for particulate matter in three states (Tamil Nadu, Maharahstra and Gujarat). The scheme is focused on meeting National Ambient Air Quality Standards.

India has a number of indirect carbon emission trade schemes:

- India's Performance Achieve and Trade scheme issues tradeable energy saving credits to companies that exceed energy saving reduction targets. It is expected to save energy use equal to approximately 6.6 million tonnes of oil equivalent by 2014-15.
- Its Renewable Energy Certificate scheme imposes obligations on power companies to produce renewable energy. Those that produce renewable energy are issued tradeable certificates that can be purchased by those which fail to meet their obligations.
- India also takes part in global carbon markets through the UNFCCC's Clean Development Mechanism, trading in Certified Emissions Reductions.

Answer

The Department of Foreign Affairs and Trade and the Department of Climate Change and Energy Efficiency are not in a position to comment on the reasons behind US Congressional decisions. We note that the United States has provided approximately 40 per cent of the total funds to the IPCC Trust Fund since its inception in 1989, including a contribution of 1.9 million Swiss Francs in 2011. The United States further contributes to the IPCC through hosting a Technical Support Unit and supporting the operation of the IPCC Data Distribution Centre.

The IPCC Trust Fund is administered under the Financial Regulations of the World Meteorological Organization. The IPCC Financial Procedures are consistent with the International Public Sector Accounting Standards. The IPCC Plenary (comprised of the 195 member governments, including Australia) adopts a budget for the IPCC Trust Fund by consensus prior to the commencement of the financial year.

Australia participates in IPCC plenary sessions where decisions are taken about the IPCC work program and where reports are accepted, adopted and approved.

Answer

DFAT is aware that an online newspaper *The Maravi Post* reported allegations, in an article published on 26 October 2011, that Paladin Energy engaged in corrupt practices.

The article also noted that prominent student and civil society activist, Robert Chasowa (who had made allegations of corruption against the company), had died in circumstances which remain unclear. The article implied that the company was knowingly involved in the death.

The Maravi Post subsequently printed a correction on 22 November 2011 withdrawing the allegations as false.

Rick Crabb (Chairman, Paladin Energy) wrote to the Australian High Commissioner to Malawi (Matthew Neuhaus – based in Harare) on 21 November 2011 confirming that the allegations were false.

Malawi's President, HE Mrs Joyce Banda, announced during her State of the Nation address on 18 May 2012 the establishment of a Commission of Enquiry into the death of Robert Chasowa. The enquiry is ongoing and our High Commission will continue to monitor this case.

Answer

- (A) We are unaware of any African Mining Vision workshops relating to uranium. The International Atomic Energy Agency (IAEA) hosted a seminar (Seminar on Good Practices in the Processing and Control of Uranium Ore Concentrate) in Windhoek, Namibia 23-27 April 2012. A list of participants is provided at Annex A (attached).
- (B) The firm Mantra Tanzania was represented at the IAEA seminar. We are not aware of its relationship with any Australian entities. We understand Mantra Resources Limited was acquired by and merged with Russian company JSC Atomredmetzoloto (ARMZ) and was subsequently delisted from the Australian Stock Exchange on 15 June 2011.
- (C) The issue of modifying the boundary of the *Selous* game reserve in Tanzania was on the agenda of the World Heritage Committee Meeting (24 June 6 July 2012). As Australia is not a member of the Committee, we are not involved in the decision-making process on this issue.

In Indonesia and Timor Leste, could you indicate what the scope of that fund [Direct Aid Program] would be and details of how it has been expended in Indonesia and Timor including a tender process?

Answer

The Direct Aid Program (DAP) is funded on an annual basis by AusAID and administered by the Department of Foreign Affairs and Trade (DFAT). Through it, the Government funds small community-level development projects, typically of between \$5,000 and \$30,000. The total global DAP budget is currently \$10 million.

In 2011-12, the DAP budget for Indonesia is \$242,000. This is split between our embassy in Jakarta, which received \$190,000, and our consulate-general in Bali, which received \$52,000. In Jakarta, projects funded this financial year have focussed on education, economic empowerment, religious tolerance and sports development in an impoverished community. In Bali, projects have focussed on community health, education, economic empowerment, the environment, advancing the interests of persons with disabilities and providing support to victims of child trafficking.

The 2011-12 DAP budget for East Timor is \$100,000. This is administered by our embassy in Dili. Projects funded this financial year have focussed on water and sanitation, education and training, community economic empowerment (particularly for rural women and people with disabilities) and governance.

In both countries, projects have been selected on the basis of applications received from the general public and opportunities identified by officers at post.

Given the program's nature, it does not involve a tender process.

Is there anything that would come within your remit that would take into account possible anti-competitiveness between domestic trade and export trade? Is that something that would raise alarm bells with you from a trade perspective? In the same way I would ask that you extend that question on notice to competitive barriers between states. Looking at Queensland and New South Wales, for example, export of live animals is a very important aspect of Queensland's trade, whereas that from New South Wales is practically negligible – raising the question of a barrier in competitiveness for a producer in each of those two states in their ease or freedom of conducting their trading activities. When I say 'between' states, I am talking now about, if you like, those decisions that are available, for example, to a Queensland producer or vice versa, given the fact that the Queensland producer would normally have access to two elements of trade – export and domestic – whereas the New South Wales producer would normally be looking at the domestic trade.

Answer

The Department is not aware of industry concerns about this issue. The regulations applicable to Australian exporters provide the assurance that exports of feeder and slaughter livestock are handled in accordance with international animal welfare standards. State and territory governments regulate Australian domestic trade in feeder and slaughter livestock to meet the required standards.



Five rounds of TPP negotiations were held in in FY11/12 (Chicago, Lima, Kuala Lumpur, Melbourne and Dallas) as well as 14 inter-sessional meetings. There are more than 20 negotiating groups which operate in the negotiations.

Total travel and accommodation for DFAT negotiators in FY11/12 was approximately \$900,000.

Australia hosted the 11th round of TPP negotiations from 1-9 March 2012 at the Melbourne Convention and Exhibition Centre (MCEC).

The round was attended by over 500 government officials from the 9 participating countries as well as 250 stakeholders.

The overall cost of the venue, including security, communications and food and beverage was approximately \$484,000. Travel and administrative costs for DFAT staff running the event was approximately an additional \$12,800.

(A) The Australian Government would welcome a high-quality FTA with China which serves Australia's trade and investment interests. Negotiations are ongoing, but they are difficult because of the range of interests and sensitivities on both sides. Discussions continue in order to narrow the differences.

The Department led Australia's negotiating team during three further rounds of FTA negotiations in 2011-12 (July 2011, November 2011 and March 2012). Australia hosted two of these rounds. Senior officials conducted additional discussions in February and May 2012, and the Department has supported high-level political engagement with Chinese leaders to discuss options for accelerating the FTA. This included the Minister for Trade and Competitiveness, Dr Craig Emerson's, meetings with China's Commerce Minister Chen Deming in Beijing and Paris in May 2012, Canberra in April 2012 and in June on the margins of APEC meetings.

Senate Foreign Affairs, Defence and Trade Legislation Committee Budget Estimates 2012–2013; May 2012

- (B) It is not the Department's position to comment on specific requests made and positions taken within negotiations, as this might prejudice the outcome of negotiations.
- (C) On 8 December 2011, DFAT and Austrade co-hosted a business networking luncheon in Sydney. It was not an FTA negotiating session. The event was attended by the Chinese Consulate-General in Sydney and officials from China's Ministries of Agriculture and Commerce, the China Development Bank, provincial commerce bureaus, and executives from eleven Chinese companies.

On the Australian side, in addition to DFAT and Austrade, the lunch was attended by representatives from agricultural industry associations, experts and consultants from institutions such as Sydney University, CSIRO and a range of major consultancy firms, as well as a small number of Australian companies with agricultural interests.

There were no formal discussions and no specific outcomes were agreed at the lunch.

 - . recruits and trains staff with appropriate linguistic and cultural competence, and uses qualified interpreters to ensure effective communication;

 - . consults appropriately with communities and client groups about regulations, the implementation of programs, and the delivery of its services.

The department's Workplace Diversity program ensures that its workforce reflects the Australian community it serves by providing opportunities to attract and retain Aboriginal and Torres Strait Islander staff (currently 46) and staff with a disability (currently 30).

On arrival at post all officers receive a country-specific cultural briefing.

(A) The Office of the Australian Information Commissioner (OAIC), established under the Australian Information Commissioner Act 2010, provides advice to all agencies governed by the Freedom of Information Act 1982 with respect to responding to FOI requests. This advice is available at http://www.oaic.gov.au/publications/guidelines.html#foi guidelines. From time to time, this advice is updated. In recent months, there have been some updates to these guidelines. The online version represents the most up-to-date version of the advice.

The Department of the Prime Minister and Cabinet provided FOI Guidance Notes to all departments on 28 July 2011. This is available at http://www.dpmc.gov.au/foi/guidance_notes.cfm. There has been no update to this advice since it was issued.

- (B) Each year, DFAT compiles information on staff-hours and non-labour costs relating to FOI, which is provided to the Office of the Information Commissioner (OAIC). The OAIC uses its own methodology to estimate the cost for each agency. This final cost information is published on the OAIC website in the Freedom of Information Act 1982 Annual Report. For 2011-2012, DFAT provided its inputs to the OAIC, including estimated total staff-hours of 13710 and nonlabour costs of \$9562.
- (C) In terms of requests received, requests processed and processing times, DFAT provided the following data to the OAIC covering the period 1 July 2011 – June 30 2012.

DFAT received 175 FOI requests between 1 July 2011 and 30 June 2012. During that period,

- 33 requests resulted in access being granted in full,
- 84 requests resulted in access being granted in part,
- 28 requests resulted in access being denied in full, and
- 53 requests were withdrawn.

A range of extensions of time are permitted under the FOI Act. Response times over 30 days do not necessarily indicate that the response is overdue, once statutory extensions are allowed for. Nevertheless, in some cases the Department's response has occurred after the processing time has elapsed. As at 17 July 2012, there are two requests outstanding for which processing time has expired.

Where delays occur, these are usually associated with large and/or complex requests, which require extensive analysis and consultation. The Department has an obligation under the FOI Act to ensure that it makes sound decisions. The Department has experienced a significant increase in the number of FOI requests since the introduction of the FOI reforms in November 2010, including three times the rate of complex FOI requests.

Kangaroo exports were discussed by Ministers at the following meetings:

- In December 2009, then Minister for Agriculture, Fisheries and Forestry, the Hon Tony Burke MP, met the Russian Minister for Agriculture, Dr Elena Skrynik, in the margins of the UN Food and Agriculture Organisation Conference.
- . In 2010, then Minister for Foreign Affairs, the Hon Stephen Smith MP, met Russian Agriculture Minister Skrynik during his visit to Russia.
- . On 16 March 2011, during the Australia Russia Agricultural Working Group (AWG) meeting, the Hon. Dr Craig Emerson, Minister of Trade, met the Russian Minister of Agriculture, Dr Elena Skrynnik.

China
