
In answer to a question from statement by me (page 77 of *Proof Hansard* 19 October 2010), I stated that I also understand that once the contract is signed Hi Fly will be applying for an Australian Aircraft Operating Certificate and Regular Passenger Ttransport designation. This information was incorrect because Hi Fly are not required to hold an Australian Aircraft Operating Certificate to meet the contract requirements. Hi Fly will comply with Civil Aviation Safety Authority and Australian Defence Force airworthiness requirements, that require charter aircraft carrying Defence passengers to hold a Certificate of Air Worthiness from one of the following five countries/regions i.e. Australia, Canada, New Zealand, Europe and United States of America and be certified for Regular Passenger Ttransport.

I apologise for any misunderstanding that may have arisen.



I write to clarify evidence that was given at the Additional Budget Estimates hearing held on Tuesday 19 October 2010 concerning Project LAND 121 Phase 3, Medium Heavy Capability.

In answer to a question to me from Senator Humphries, pages 87-88 of the Hansard for Tuesday 19 October, the Chief Executive Officer of the Defence Materiel Organisation, Dr Stephen Gumley stated that the value of the Medium Heavy Capability element of Project LAND 121 Phase 3 was \$1.7B. This amount did not include the normal contingency funding provision for the project. The full total, including contingency provision, is \$1.9B
