## Senator Allison asked: What was the changed decision based on?

**Answer:** As indicated in the media release of 6 December 2002 by the Minister for Transport and Regional Services, the Hon John Anderson MP, the government reconsidered its position on the National Highway upgrade through Albury Wodonga after the strong representations made by the two Federal Members, the Member for Farrer, Sussan Ley, and the Member for Indi, Sophie Panopoulos.

These representations included an assessment of the safety, cost and timing implications of the options under consideration for the National Highway upgrade through Albury Wodonga.

The government also took account of representations of local Councillors Mayor Patricia Gould of Albury and Mayor Lisa Mahood of Wodonga, made on behalf of the local community.
