Senator Evans asked on 15 February 2005:

- (1) Please provide figures on overall numbers of NSA and YA incapacitated paid in 2003-04, and 2004-05 to March 2005, plus an additional breakdown by age and gender for the periods listed.
- (2) Can we have the figures of recipients that were newly granted NSA and YA incapacitated in each of the last three financial years?
- (3) Could we have data on type of 'flexible' or 'partial' Preparing for Work Agreements (PfWAs) granted to clients on who have exited from NSA and YA incapacitated payments for each of the last two financial years, based upon the work capacity as assessed using the bands available to Centrelink?
- (4) Could we have data for people over the last two financial years about the length of time a person was on NSA and YA incapacitated before their were exited from the payment?
- (5) Can we have details of the numbers of medical certificates that were not accepted by Centrelink from customers seeking an activity test exemption, of currently on an activity test exemption?
- (6) Could we have information on the number of recipients in the last financial year who move from a full activity test exemption to the normal activity test requirements for NSA or YA?
- (7) Could we be provided with an outline of the range of support services available to those on NSA and YA incapacitated and after they are placed on full activity test for NSA and YA?
- (8) Could we have a breakdown of the types of incapacity or health problems experienced by recipients on NSA and YA incapacitated (eg mental health conditions) for the last two financial years?
- (9) Of those who have been exited from NSA and YA incapacitated over each of the last two financial years, could we be provided with data on length of time on NSA and YA incapacitated?
- (10) Could we have data on the number of recipients breached within the 12 month period they go off incapacitated payments, over the last two years?
- (11) What research has the Centrelink undertaken into incapacitated clients or the 'Better Assessment' policies since they were introduced in September 2002? Is there any research that you are planning to do? If there is any research, could the findings be provided?
- (12) What are the actual employment outcomes of the 'Better Assessment and Early Intervention' changes introduced in 2002, for each of the last two financial years and the use of work capacity assessors?
- (13) What issues arise for Centrelink, Job Network providers and recipients in circumstances where they have had a medical certificate for an exemption rejected by Centrelink, and they then proceed to hand this same certificate to the Job Network provider?

Answers:

(1) The Newstart Allowance and Youth Allowance population breakdown, including an age and gender breakdown as at 18 June 2004 and 18 February 2005 is provided below. Note: There is no Newstart or Youth Allowance incapacitated payment. Newstart or Youth allowee job seekers requesting an exemption from the activity test lodge medical certificates and may be granted an exemption because of an incapacity.

- (2) Centrelink does not source or report data on the number of recipients that were newly granted Newstart Allowance and Youth Allowance.
- (3) Centrelink does negotiate flexible Preparing for Work Agreements with job seekers. The activities negotiated for inclusion in a Preparing for Work Agreement take into consideration the job seeker's individual circumstances including their education, skills, age and physical condition, including the impact of any disability or medical condition.

Centrelink does not collect specific information which distinguishes when a flexible (modified) Preparing for Work Agreement is negotiated. All Preparing for Work Agreements can be tailored to meet individual needs.

- (4) Centrelink does not source or report data relating to movement from exemptions to normal activity test requirements.
- (5) The data below shows total Newstart Allowance and Youth Allowance customers medical certificate lodgements for 2004 including a breakdown of exemptions granted and those not granted.

- (6) Centrelink does not source or report data relating to movement from exemptions to normal activity test requirements.
- (7) Newstart Allowance or Youth Allowances (incapacitated) job seekers may be assessed by professional assessors to determine their capacity to work. The professional assessors include work capacity and medical assessors and psychologists. They provide an assessment report to Centrelink which helps determine the customer's activity test requirements, informs Centrelink of the barriers the customer faces and makes recommendations for assistance to overcome these barriers.

Centrelink provides the options listed in the assessment report to the customer. These range from community options eg. referral to community health centres and State Government programs to Commonwealth funded program participation eg. Personal Support Program, disability specific employment assistance, Job Network assistance or other Commonwealth programs.

If the job seeker is exempted from the activity test then participation in any of the programs is voluntary. Those job seekers who do not receive an exemption from the activity test are required to participate in appropriate options meeting the requirements of the activity test.

(8) Centrelink has supplied the medical conditions of Newstart Allowance and Youth Allowance (job seekers), by the first reported medical condition on their medical certificate.

- (11) Centrelink has not conducted any specific research of the Newstart and Youth allowance (incapacitated) population.
- (12) Centrelink's role with Newstart and Youth Allowees under the "Better Assessment and Early Intervention" measure introduced in September 2002 is to refer customers for an assessment (medical, work capacity or psychologist) and to use the information from the assessment report as well as other customer information to determine activity test requirements and offer appropriate assistance. Centrelink is not the funding agency for any assistance provided and does not measure outcomes of programs, whether Commonwealth or State funded, to which customers are referred. Question 12 is best referred to the relevant funding agency.
- (13) Centrelink is the delegate for determination of activity test exemption requests. If a medical certificate has been provided to Centrelink for the purpose of requesting an exemption from the activity test and Centrelink determines that an activity test exemption is not appropriate, the job seeker must meet activity test requirements. This includes participating with the Job Network member to which they have been referred.
