Answer:

- 1. The seven Commissioners were appointed on 10 March 2005.
- 2. As required under the *National Water Commission Act 2004* each Commissioner has a high level of expertise in an area relevant to the functions of the National Water Commission including, but not limited to, water resource management, freshwater ecology or hydrology, resource economics, public sector governance and the audit, evaluation and implementation of programs relating to natural resource management. Each Commissioner is appointed on an individual basis, and not as representative of either a state or federal body.

The Commissioners are:

- Mr Ken Matthews AO, who has been appointed as Chairman and Chief Executive Officer of the Commission. Mr Matthews is a former Secretary of the Commonwealth departments of Transport and Regional Services and Agriculture, Fisheries and Forestry, and has extensive experience in public sector governance;
- Mr Peter Corish, a primary producer with expertise in water resource management and currently president of the National Farmers' Federation:
- Dr Walter Cox PSM, who is currently Chairman of the Western Australian Environmental Protection Authority and the Murray-Darling Basin Independent Audit Group and who has relevant public sector governance, water resource management and natural resource management programme audit, evaluation and implementation expertise;
