SENATOR COONAN asked on 22/02/2008:

Proof of Arrival / Proof of Birth (Commencement of Identity):

What are the current Proof of Identity requirements to minimise the risk of fraudulent claims?

Answer:

Centrelink maintains a Proof of Identity model with a tiered approach based on the 100 point check system detailed in the *Financial Transactions Reporting Act 1988*.

To satisfy the 100-point check system, a person must provide Proof of Arrival or Proof of Birth plus documents to the value of 100 points from the following list:

Original Australian Birth Certificate, extract or birth card in name/former name.	70
Current Australian passport in name/former name.	70
Australian citizenship certificate in name/former name.	70
Australian visa, current at time of entry to Australia as resident or tourist, in name/former name. Document of Identity issued in name/former name by the Department of Foreign Affairs and Trade (DFAT)	70
to Australian citizens or persons who possess the nationality of a Commonwealth country, for travel purposes. Certificate of Evidence of Resident Status (Form 283) issued by the Department of Immigration	70
and Citizenship (DIAC), showing name/former name.	70
Certificate of Identity issued by the DIAC to refugees and non-Australian citizens for entry to Australia. Australian Defence Force discharge papers in name/former name.	70 70
Current Shooter's or Firearm Licence showing signature and/or photo and same name as claim.	70
Current Security Protection Industry or Crowd Control Licence, showing signature and/or photo and same name as claim.	70

Centrelink's tiered system requires claimants to provide Proof of Identity for different payments as follows:

Tier 0: No Proof of Identity required:

Family Tax Benefit Part A, Family Tax Benefit Part B, Child Care Benefit, Maternity Allowance, Maternity Immunisation Allowance, Residential Care Assistance, Assistance for Isolated Children, ABSTUDY Schooling Allowance, Partner of Commonwealth Seniors Health Card Holder.

Tier 1: Proof of Birth / Arrival (cardinal document) OR Other Approved Documents to the value of 50 points: Low Income Health Care Card (including partner), Commonwealth Seniors Health Card, foster care Health Care Card, job match services only, residential aged care.

Tier 2: Proof of Birth / Arrival (cardinal document) AND Other approved Documents to the value of 50 points: Mobility Allowance, Carer Allowance including care receiver.

Tier 3: Proof of Birth / Arrival (cardinal document) AND Other Approved Documents to the value of 100 points: Disability Support Pension, Sickness Allowance, Carer Payment, Wife Pension, Student Financial Supplement Scheme, Youth Allowance, Austudy, ABSTUDY, Exceptional Circumstances Relief, Farm Help, Retirement Assistance for Farmers, Partner Allowance, Bereavement Allowance, Pensioner Education supplement (DVA customers only), Mature Age Allowance, Newstart Allowance, Widow Allowance, Special Benefit, Parenting Payment (Single), Parenting Payment (Partnered), Age Pension, Widow B Pension, Application to provide Assurance of Support.
