Written Questions on Notice

CC7-DCC (BIRMINGHAM)

Did the Renewable Energy Council write to Mr Garrett prior to the announcement of the new rebate scheme for solar panels, urging him not to use the RECs as a basis for the rebate? If so, can the Department please elaborate on his concerns? Why was his advice ignored? Please provide a copy of the letter.

CC8-DCC (BIRMINGHAM)

Solar installers expressed concern that they will have to pay the home owner the thousands of dollars up front for the RECs. Is that true? What happens if the value of the RECs falls before they sell them?

CC9(a-e)-DCC (BIRMINGHAM)

In relation to the comparative benefits of the old rebate system under the Coalition and the proposed new Government system:

- a) How much will a person living in Melbourne who installs a one kilowatt solar system actually receive in the hand as payment by an average solar installer or retailer?
- b) Is it technically possible that a person in Melbourne buying a one kW system could be \$4500-\$5000 worse off than under the previous Coalition rebate system which provided an \$8000 rebate to all?
- c) How does this compare with the modelling by Colin Gillam, of Melbourne company Solar Sunwerx, who found that consumers could end up with almost \$5000 worth of extra costs than under the current scheme, depending on where they live and the size of the system installed?
 - a. In a 29 January report in *The Australian* newspaper, Mr Gillam found that people installing solar systems in Melbourne could be up to \$4600 worse off, while those in other state capitals could find themselves out of pocket by up to \$4000.
 - b. Could these figures be correct? If not, please provide the modelling supporting any dispute of the figures?
- d) Please provide modelling which shows exactly what rebate home owners would receive as a rebate under the new scheme, for each capital city, and for solar units of 1.0, 1.5, 2.0, 2.5 and 3kW.

- a) Now that the Garnaut process has been completed, can you please advise what the total cost of the Review was?
- b) Please provide a final break down of Professor Garnaut's salary, administration and associated costs.
- c) Was an assessment carried out into the value or conduct of the inquiry?
- d) What were the results?

CC21(a-e)-DCC (JOHNSTON)

Penny Wong's department spent \$18,000 to print the Garnaut Report on special paper from Italy. The paper was reported to be 80 per cent recycled and 20 per cent chlorine free pulp and from 'well-managed' forests.

- a) What emissions were expelled in transporting this paper to Australia?
- b) Why didn't you use recycled Australian paper?
- c) What is wrong with using Australian paper?
- d) How much more did it cost to use the imported Italian paper?
- e) What other publications are you or your department using this Italian paper for?
 - a. Please provide details, costs, dates, etc

CC22(a-g)–DCC (JOHNSTON)

In regards to ZeroGen:

I refer to a letter from ZeroGen CEO Dr Anthony Tarr of 12 January 2009 who said that under the Government's CPRS: "The perverse situation would be that projects such as ZeroGen would need to pay for the permits to emit whilst the dirtiest coal generators in Australia are given permits free of cost!" and that the CPRS would be a "significant barrier" to the development of clean coal in Australia.

- a) What have you done to overcome this disparity?
- b) What assistance will you provide to research organisations such as ZeroGen to ensure they are not unfairly deal with under your emissions trading scheme?

Dr Tarr's letter went on to say: "Minister Wong's office seems to believe that the introduction of a CO2 price will provide the only necessary impetus to developing low-emissions technologies – but ignores the fact of economic and practical reality that alone this will simply not be enough."

- c) Do you concede that your office has failed to alleviate the concerns of one of the leading clean coal research facilities in Australia, praised by the Prime Minister, who at the time said clean coal was "critical for Australia's economic environmental future."
- d) How do such comments stack up in the face of such criticism of clean coal researchers?
- e) Why was the entire team of the Business Development and Corporate Affairs team at ZeroGen disbanded?
- f) Please provide details of the job losses
- g) Whose decision was it to retrench the workers?

CC23(a-b)–DCC (WILLIAMS)

- a) The CPRS proposes that passenger and truck transport emission costs will be offset for 3 and 1 years respectively, resulting in no cost increase to users. Since there is therefore no incentive to change, why will travel behaviour change to reduce transport emissions?
- b) The Government proposes to exclude emissions intensive trade exposed industries, offset road transport emission charges and compensate households (so the CPRS should perhaps be more accurately called an Omissions Trading Scheme). Consequently, cost effective emission reductions will not occur in these sectors and must instead occur by less efficient abatement in other sectors. What then is the increased cost to business and the community of the CPRS due to the most efficient abatement not being used?
