- a) What was the cost of the Minister's travel and expenses for the Community Cabinet meetings held since Budget Estimates?
- b) How many Ministerial Staff and Departmental officers travelled with the Minister for the Cabinet meeting?
- c) What was the total cost of this travel?
- d) What was the total cost to the Department and the Ministers office?

#### Answer:

a) Eight Community Cabinet meetings have been held since Budget Estimates 2009. The Minister for Finance and Deregulation attended five of those meetings. Travel costs were \$8,103.39 and expenses were \$774.00.

Note 2—The above figures include airfares, Travelling Allowance (including Motor Vehicle Allowance) claims and Comcar charges. They do not include travel by taxis (due to the difficulties determining exact destinations using the electronic information as provided by Cabcharge) or travel on Special Purpose Aircraft (which is administered by the Department of Defence).

Note 3—The travel cost information provided includes additional destinations for the Hon Lindsay Tanner MP when he attended the Community Cabinet meeting in Beenleigh, Qld. Given the nature of the flight bookings, the costs of the additional destinations are not able to be disaggregated from the cost of travel to attend Community Cabinet meetings.
