**Senator FAULKNER**—Could you provide copies of the heritage assessment and the valuation of these to the committee, please?... I would also be interested to hear about the status of the other billiard or pool tables and what their heritage values might be. In other words, which of these may have come from Old Parliament House and what is the historical background of their acquisition or transfer to new Parliament House? I would appreciate that information, if it could all be made available.

**Answer**

1 All acquisitions were done by the Parliament House Construction Authority and transferred to the then Joint House Department in 1989. Two of the billiard tables acquired were reconditioned Old Parliament House ones, and have since been returned to Old Parliament House (February 2000).
