Answer:

The Office of National Assessments does not arrange travel for the Prime Minister, Ministers, Parliamentary Secretaries and/or Parliamentary staff.

The total ONA cost for domestic travel expenses from 1 July 2011 to 31 January 2012 is \$75,492.09. This includes 89 domestic trips.

The total ONA cost for international travel expenses from 1 July 2011 to 31 January 2012 is \$798,017.63. This includes 69 international trips.

ONA officials fly economy class for domestic travel. SES officers fly economy for Sydney and Melbourne sectors and business class on all other domestic flights.

ONA officials fly business class for international travel taking the most direct route. There are occasions when international travel is taken in economy class due to availability and routing.

Six ONA officials have Qantas Club memberships at a total cost of \$1,365 per annum.

The Director General was accompanied by the ONA Executive Officer on one trip at a cost of \$21,889. The Executive Officer provided administrative support.

ONA does not record travel data in a way that would readily allow more detailed answers to be provided to these questions. To attempt to provide this level of detail would involve an unreasonable diversion of departmental resources.
