b) For the period to 31 January 2013 the following travel was undertaken:

In January 2013, the First Assistant Parliamentary Budget Officer, Budget Analysis Division, attended the Committee on Fiscal Affairs and Organisation for Economic Co-operation and Development (OECD) - International Monetary Fund (IMF) conference on 'Fiscal Policy for Greener Growth'.

The total cost for this travel was \$9,902.13, comprising \$8,346.52 for an international flight, \$1,205.84 for accommodation, \$147.14 for transport, and \$202.63 for meals and incidentals.

In February 2013, the Parliamentary Budget Officer attended the 5th Annual Meeting of OECD Parliamentary Budget Officials and Independent Fiscal Institutions in Ottawa, Canada.

The total cost for this travel was \$11,524.01, comprising \$10,548.74 for an international flight, \$689.74 for accommodation, \$17.60 for transport, and \$267.94 for meals and incidentals.

- c) The First Assistant Parliamentary Budget Officer, Budget Analysis Division is the Chair of an OECD working party and will travel to Paris for meetings of the working party on 21-24 May 2013. The meetings concerned are OECD Committee on Fiscal Affairs, Working Party 2 (WP2) on Tax Policy and Statistics (21-23 May) and for the Joint Committee of Tax and Environment Experts (JCTEE) 24 May.
