 - a) APS job classification;
 - b) gender; and
 - c) days of the week.

Please provide a list of each category of unscheduled absences (sick leave, carer's leave and other) for the five worst-performing large Australian Public Service agencies (i.e. agencies with over 1,000 APS employees) in each of the five years to 2011/12.

Answer:

- 1a) The Secretaries Board discussed:
 - total unscheduled absence days per employee by absence type for small, medium and large agencies, drawing on data from the 2012-13 State of the Service Report Agency Survey
 - those agencies with the highest and lowest absence rates
 - strategies identified by the best performing agencies in their responses to the State of the Service Agency Survey
 - 1(b) The Secretaries Board considered a paper that drew together the data listed above
- 1(c) The Secretaries Board noted that:
 - further research and analysis was being undertaken on the issue by the Australian Public Service Commission; and
 - The issue would be the subject of further discussion by Secretaries.
