# Prime Minister and Cabinet Portfolio Australian Public Service Commission

Budget Estimates Hearings 2003-2004, 29 May 2003

**Question: PM74** 

**Topic: APS Employment Database** 

# Senator Carr asked:

In the Public Service Commissioner's annual report you concede there are still problems with the 'integrity of the data' on the APS employment database, especially in relation to 'quality and quantity' of the data. Can you confirm that?

#### Answer:

The Commission considers that maintaining and improving the quality of the APS Employment Database is essential to providing useful analysis. This work is ongoing, however, there has been improvement in the quality of data over the last twelve months.

# Senator Carr asked:

2. What's the problem?

#### Answer:

The complexity of collecting data from over 90 agencies, using a variety of HR systems, means that data coming from agencies is sometimes not in the format we require, or is incomplete. Staff in the APSED team continue to work closely with agencies and vendors of HR systems to assist them in ensuring that their data complies with our requirements.

### Senator Carr asked:

3. Have extra staff and/or resources been devoted to fixing it?

# Answer:

We encourage agencies to provide data more regularly throughout the year, rather than in one larger amount at the end of the financial year, putting pressure on the APSED team to deal with an uneven workflow.

Extra staff have been employed to deal with the extra work load at the end of the year. Resources continue to be applied to liaising with agencies to encourage them to provide better quality data in a more timely manner.

In addition, planning has begun on a project that will, when fully implemented, ensure that some data verification currently done within the Commission be undertaken by agencies before they send data to APSED. This will ensure that data received by APSED has fewer errors.

# Senator Carr asked:

4. Have any costs outside what you estimated been incurred because of the problems? How much?

#### Answer:

In addition to normal staffing, one extra employee at the APS 3-4 level has been employed on a non-ongoing basis for a year with salary cost approximately \$40,000 per year. Prior to this date, we also engaged extra processing staff as required. The cost for this for 2002-03 is approximately \$22,000.

# Senator Carr asked:

5. What has the project cost to date? What is the total budget for it? Has that been altered?

### Answer:

During 1998-99 and 1999-00 the Commission spent \$188,701 on a consultancy for the development of APSED. This amount includes changes made to APSED due to the introduction of the *Public Service Act 1999*. In addition to normal staffing levels, an amount of \$14,000 has been allocated annually for maintenance and enhancements to APSED. The price for APSED during 2001-02 (including staffing and administration costs) was \$1,076,000.

#### Senator Carr asked:

6. I understand the database was supposed to be a critical tool for workforce analysis and planning. What has happened to this critical work given the problems with the database?

#### Answer:

Despite problems with the quality and timeliness of data received from agencies, the edit checks and business rules applied in the Commission ensure that the data stored on APSED provides a reliable picture of APS staffing trends. This data was used extensively in the Management Advisory Committee report on Organisational Renewal, released earlier this year, as well as in the annual State of the Service and Workplace Diversity Reports. The first of a new series of research papers, Graduate Trends, was also released earlier this year.

Individual agencies also continue to use APSED data to supplement analyses of their own data, for workforce planning.

# Senator Carr asked:

7. We have already covered the very distressing results of the Organisational Renewal report which makes clear that workforce planning has not been very well carried out in the past, and that it is critical to the future of the service. What are you doing to fix the problems with the database?

# Answer:

As well as the steps outlined in answer to Questions 2 and 3, work is also underway on developing an internet interface, through which agencies will be able to access their own APSED data for workforce planning.

# Senator Carr asked:

8. The annual report says you are 'working with agency heads to improve the data, and expect to have more reliable data as the basis for reporting in 2002/2003'. Is that in fact the case given we are close to the end of that period?

#### Answer:

We do not yet have complete data for all agencies for the 2002-03 financial year. However, data provided to date indicates that data quality continues to rise, as agencies and HR vendors become more familiar with the APSED requirements.

### Senator Carr asked:

9. When do you expect you will have the system running at full strength rather than just providing 'more reliable data'?

# Answer:

Due to the nature of administering a database such as APSED, work on improving data quality is ongoing.

Topic: Non-ongoing staff

# Senator Carr asked:

- 10. I've been looking for comprehensive information on these non-ongoing employees and have found very little. At least not nearly the level of detail as there is for full-timers. Could you provide the following:
  - (a) a breakdown of the number of non-ongoing staff by agency and by category comparing this year's figures with those of previous years.
  - (b) a statistical breakdown of the median length of service for these employees by agency.

# Topic: Cost of the APS Commission Office

# Preamble

The Commission sets out its Outcome and Outputs and strategic priorities in its Corporate Plan – a copy of the APS Commission Corporate Plan 2002-03 and Beyond is attached as an indication of our approach (Attachment C). The Outcome and Output structure is included in the Portfolio Budget Statements with quantitative and qualitative performance information. The PBS also identifies the cost to Government of the Commission's Outcome and each of its Outputs and the revenue to be earned from other sources. The Commission reports in some

detail against this framework in its Annual Report. The Annual Report provides a public analysis of the Commission's performance against its Corporate Plan and budget commitments (PBS), including where we have encountered difficulties during the year, for example, our reporting in relation to the APS employment database during 2001-02. The Annual Report accounts for the Commission's expenditure of taxpayer funding.

The Commission receives funding from Government and relies on the sale of goods and services to earn revenue to fulfil the breadth of its legislated responsibilities. In particular, revenue generation is significant to the Commission's responsibilities relating to coordinating and supporting APS-wide training and career development and fostering leadership. These learning and development activities are undertaken in a competitive market place, which ensures that the Commission's products and services are of high quality, relevant and competitive.

#### Senator Carr asked:

11. I see from the PM and C Portfolio Budget Statement (p. 98) that next financial year the Commonwealth will spend over \$15 million on the Commission. What is the taxpayer getting for their money?

# Answer:

Broadly the Commission contributes to the development of a confident, high quality, values-based and sustainable Australian Public Service (the Commission's *Outcome*)

The Commission's particular contribution is through:

o APS policy and employment services

Providing advice to Government and Agency Heads on APS policy and legislation, including in relation to the employment framework and SES staffing.

Leadership, learning and development services

Promoting effective leadership in the APS and providing APS-wide learning and development activities.

Organisational performance, promotion and support services

Promoting the APS Values and Code of Conduct and fostering better practice governance, people management, client service and workplace diversity.

Evaluation services

Evaluating specific issues, maintaining a database of APS employees and reporting annually to Parliament on the performance and composition of the APS.

Merit protection and other services

Conducting reviews of actions relating to APS employees' employment and breaches of the Code of Conduct, and investigating whistleblowing allegations.

The level of *Outputs* is set out in the Portfolio Budget Statements and Annual Reports.

# Senator Carr asked:

12. How does that allocation compare with previous years?

#### Answer:

The Commission's appropriation from Government for the financial years 1999-00 to 2002-03 follows:

# Senator Carr asked:

13. And you estimate you will raise over \$12 million from other sources. What are those other sources and are you on track to make that figure.

# Answer:

The major sources of these funds are the sales of goods and services, for example, fees from leadership, learning and development activities, employment related fee for service activities (which include constituting Independent Selection Advisory Committees and scribing services) and gazette subscriptions.

The Commission's performance to the end of May this financial year indicates that we are on track to achieve this target and the likely end of year position is that we will earn \$12.295 million from these sources.

# Senator Carr asked:

14. What did you earn from outside over the 2002/03 and years before that?

# Answer:

Revenue from other sources:

There has been a steady incline in the Commission's earnings from the sale of goods and services during this period which arises from increased demand for the leadership, learning

and development program and employment related services such as independent selection advisory committees.

# Senator Carr asked:

15. Can you do everything you want to do on a total budget, including Commonwealth and outside earnings, of a little over \$27 million a year.

# Answer:

The short answer is that the Commission has been able to consistently meet the commitments in the Portfolio Budget Statement and its corporate plan through reliance on funding from Government and growth in funding derived from the sale of its goods and services.

The Commission's funding from the sale of goods and services is estimated to account for over 40% of its revenue during 2003-04. The sale of goods and services is particularly significant to the Commission's responsibilities relating to coordinating and supporting APS-wide training and career development and fostering leadership. These activities are undertaken in a competitive market place, which ensures that the Commission's products and services are of high quality, relevant and competitive. It is also a potentially volatile market as agencies can choose their source of supply and this means that the Commission must devote considerable effort to managing its budget and cashflows through the year.

The continued strength of revenue from these sources has led to the Commission establishing an accumulated surplus both as a contingency against a decline in the sale of goods and services and as a possible source of funding for future initiatives. Accordingly, the Commission is on a solid financial footing.

16. Can you give me a breakdown of the Commission's spending – how much goes on staff etc?
