Senator Forshaw asked: From the State of the Service Report 2002-03, the number of senior executive service officers has increased from 1,543 in 1998 to 1,872 in 2003. Could you give us on notice the latest figure?

Answer:

Finalised data for June 2004 will not be available until the State of the Service Report is tabled in November. Data on the APS Employment Database (APSED) is provided to the APS Commission by agencies throughout the year. In addition, a snapshot file for 30 June each year is provided by each agency by the middle of July. Data is then cleaned, analysed and reported on in the State of the Service Report.

Preliminary data for December 2003 for ongoing SES staff by agency is at Attachment A. This data is an estimate, and will be subject to revision when the 2004 State of the Service Report is tabled. Data for SES by agency at June 1998 is at Attachment B. Due to changes in agency structure between 1998 and 2003, direct comparisons are not possible for some agencies.
