Notes:

- 1. The information regarding non Government personal staff includes staff allocated to the ALP, Democrats and Independents (but excludes staff of former Prime Ministers).
- 2. Total Salary and Allowances includes Salary and applicable allowances including Parliamentary Staff Allowance, Ministerial Staff Allowance, 15% loading in lieu of leave, value of Private Plated Vehicle and District Allowance. Superannuation costs have not been included.
- 3. The value of the provision of a Private Plated Vehicle for eligible senior staff has been given as the value of the allowance in lieu of Private Plated Vehicle applicable as at 1 May each year.
- 4. The annual rate of salary and allowances (excluding the Private Plated Vehicle) in receipt by an individual staff member has been adjusted by (a) part-time hours and (b) for absences on leave without pay or half pay as at 1 May of each year. For example, a part-time staff member (working 20 hrs per week) receiving salary at a rate of \$40,000pa and Parliamentary Staff Allowance of \$12,606pa is absent on half pay on 1 May 2003: the total value of remuneration will be \$52,606, multiplied by 20/36.75 for part-time hours, then multiplied by 0.5 for leave on half pay. Please note that where a staff member who is eligible for a Private Plated Vehicle is absent on leave on half pay or without pay then the value of the vehicle is not reduced as the vehicle continues to be provided during the absence.
