I think I have made that clear. But to try to answer your question in a hypothetical way, there have been loan arrangements that this and previous governments have entered into, and some of them were sourced from basically consolidated revenue. We have provided loans to PNG. We have provided loans to other countries as part of a development aid package. Senator Hill—Also, if this was a letter from the Prime Minister, it is pretty hard for the official therefore to answer in terms of the Prime Minister's intention as it goes beyond the content of the letter. If you want to know what the Prime Minister's intention was in relation to a funding source I think you should ask the Prime Minister.
