# Amended Response to Question on Notice - Estimates Hearings May 2006

Please find enclosed a compact disk (CD) containing an amended response to written Question on Notice F50 asked at the May 2006 Senate Standing Committee on Finance and Public Administration Budget Estimates Hearings.

In preparing a response to a similar written question asked by Senator Joe Ludwig following the Supplementary Budget Estimates Hearings on 31 October 2006, we identified an omission in the total expenditure on external legal services. The amended response on the CD highlights, for the Committee's information, the amendment to part (1) of the response.

The effect of this is an increase of approximately \$6 million in the figure for external legal services expenditure for the Department of Finance and Administration for the period 1 July 2005 to 31 May 2006. This omission relates to legal services expenditure in respect of Comcover which was not captured in the previous response. This arose because the expenses have been classified as insurance claims handling on an external contractor's system. Any inconvenience caused to the Committee by this error is regretted.
