## **QUESTION: PM1**

### Senator Faulkner asked:

- "... will you be able to provide that [breakdown of costs for the Turkey/Egypt visit] to the committee when it is available? ..."
- "And you might also provide the costs of the visit, part 1 and part 2, of the outback visit as well ...."

## Response:

The cost of the Governor-General's visit to Turkey/Egypt is as follows: (a) travel \$93,230.95; (b) accommodation and meals \$52,190.86; (c) other expenses \$5,424.75. (Note that this does not include the cost of Australian Federal Police security.)

The cost to the Commonwealth of the outback visit, stages one and two, was \$114,836.70 for travel over 12 days for 8 people. (Note that this does not include the Australian Federal Police security costs or the 2 AFP security officers who participated in the visit.)

## **QUESTION: PM2**

#### Senator Faulkner asked:

"... You might take on notice then any changes to the inventory [of artworks on loan to the Office] ... 'changes', of course, means additions and subtractions.
