1. Answer:

As at 23 May 2006, PM&C led the following taskforces, interdepartmental committees or interdepartmental working groups:

1) APEC Taskforce

- a) The APEC 2007 Taskforce was established by the Australian Government.
- b) The APEC 2007 Taskforce's aim is to deliver a safe and successful APEC year in 2007. Its operational remit is to coordinate and manage the logistics of the APEC year.
- c) Membership of these groups is drawn from officials from the Commonwealth, and in relation to planning for the leaders' week, New South Wales Government officials.
- d) The senior governing body is the APEC Executive, comprising the Secretary and deputy secretaries of the Department of the Prime Minister and Cabinet (PM&C), the Secretaries of the Department of Foreign Affairs and Trade (DFAT), Attorney General's Department (AGD) and the Department of Defence (Defence), the Chief of the Defence Force and the APEC Ambassador.
- e) The deadlines for the Taskforce are the APEC meetings to be held throughout 2007. APEC Leaders' Week is the final event in the APEC 2007 year. The Leaders' Meeting will be held on 8-9 September 2007.
