Answer: a) The Commonwealth Procurement Guidelines provide for the use of direct source procurement "where, for reasons of extreme urgency brought about by events unforeseen by the agency, the property or services could not be obtained in time under open tendering procedures." Decisions about utilising the direct sourcing approach for individual supply contracts were made within the Department of the Prime Minister and Cabinet.

- c) In relation to direct source engagements, the Department communicated with authorised representatives of each of the contracted companies or organisations.
- d) PM&C considered value for money, the capacity of the provider to deliver the required services within tight timeframes, and the past history of the provider.
- e) An external legal provider was engaged to provide legal services to the Australia 2020 Summit, but their role did not include a review of procurement strategy, individual contracts or tenders.
