Regarding the vehicles that were identified in that answer that I was talking about – on the government vehicle fleet – where there was an Audi A4, nine Chrysler Voyagers, seven Mazda CX7s, two Subaru Imprezas, eight Volkswagen Golfs and a Peugeot 407, would you provide me with details about the operational need for those fully imported motor vehicles?

Answer:

The Department of Finance and Deregulation (Finance) manages the whole of government Fleet Management Agreement. Finance is responsible for the selection criteria governing fleet pool vehicles. These criteria support Australian vehicle manufacturers. To be eligible for selection, a vehicle must be either: (i) made in Australia; or (ii) imported by an Australian manufacturer and with an engine capacity of 2,000cc or less. An "Australian manufacturer" is defined as a manufacturer which has a local operation in vehicle assembly or component production and satisfies the criteria for registration as a Motor Vehicle Producer or Automotive Component Producer under the *Automotive Competitiveness and Investment Scheme Administration Act* 1999.

Where a compelling need exists that cannot be met by a vehicle sourced from an Australian manufacturer, an agency is able to select a vehicle from another manufacturer. Agencies make these decisions independently of Finance.

These guidelines apply to agencies that operate under the *Financial Management and Accountability Act 1997*. There are no vehicle selection policies applying to agencies that operate under the *Commonwealth Authorities and Companies ACT 1997*.

The Department of Education, Employment and Workplace Relations (DEEWR) is responsible for policy governing the Executive Vehicle Scheme (EVS). On 24 March 2005, DEEWR issued its APS Advice No 2 of 2005. This Advice was most recently updated by Advice No.1 of 2009 of 29 June 2009. This policy effectively mirrors the pool vehicle guidelines issued by Finance with the exception that the EVS guidelines specifically exclude the selection of "sports cars". These guidelines apply to APS Agencies (including Agency Heads) as defined under the *Public Service Act 1999*.
