- d) Have any voluntary or involuntary redundancies been offered to staff? If so, how have staff been identified for such offers? Are there any such plans for the future?
- e) What was the total cost of staffing for the Department in the financial years 2007-08 and 2008-09?
- f) What are the estimated total costs of staffing for the Department in the financial years 2009-10 and 2010-11?

v. Future Fund -

d) Redundancies:

i. Department of Finance and Deregulation – Three employees were offered involuntary redundancies in 2009 -10. These employees were identified as excess following a restructure within the business area and the elimination of the employee's job function. These employees were unable to be redeployed within the APS within the required timeframes. There are no plans for redundancies in the future.

ii. AEC -

Eleven voluntary and two involuntary redundancies were offered to staff. Redundancies have been offered to select groups or individual members of staff in relation to office closures and relocation of

functions, closure of two Electoral Education Centres and staff members being excess to operational requirements.

iii. ARIA -

One redundancy has been offered during 2010 due to changed business requirements. There are no plans for redundancies in the future.

iv. ComSuper -

ComSuper have offered ten voluntary redundancies. These have been staff that have expressed an interest in receiving a voluntary redundancy, but only when the issue of such a redundancy is seen to be of benefit to the organisation.

No involuntary redundancies have been offered to staff. At this stage, no further redundancies are planned for the future.

- v. Future Fund –
 No redundancies have been offered to staff.
- e) In 2007-08, the total cost of staffing for the Department was \$136,562,000. In 2008-09, the total cost of staffing for the Department was \$143,619,000.
- f) In 2009-10, the estimated total cost of staffing for the Department is \$154,842,000. In 2010-11, the estimated total cost of staffing for the Department is \$160,470,000.
