

Audit report No.33 2009–10 Building the Education Revolution—Primary Schools for the 21st Century: results of survey of school principals

At a Budget Estimates hearing on 25 May 2010, Senator the Hon Brett Mason expressed an interest in the survey of school principals conducted by the Australian National Audit Office (ANAO) as part of audit report No.33 2009–10.

The audit report includes the results from the weighted statistical sample of 622 principals at Appendix 2. You may recall that in conducting the survey the ANAO invited all principals to respond, from which the sample was drawn. At the hearing, Senator Mason asked whether the raw data that related to all principals who responded to the survey could be made available to the committee.

To enable ready comparison, the attached document provides the survey results in three ways:

- the stratified sample of 622 school principals, weighted to produce statistically unbiased estimates, as presented in Appendix 2 of the audit report;
- all 3781 respondents, including those in the ANAO sample, weighted to produce statistically unbiased estimates; and
- all 3781 respondents, including those in the ANAO sample, unweighted.

It is important to note that the unweighted results may be affected by response bias.

Responses to other questions taken on notice will be provided in due course.

Attachment: School principal survey—sample and all respondent results

The following tables show the results of the ANAO survey of principals, including the results for both all respondents and those in the audit sample. In calculating the percentage results, the ANAO has excluded respondents who indicated that the question was not applicable to them or did not answer the question. The number of respondents to each question is indicated in brackets following the question (for example, if 622 principals responded to a question this would be indicated in brackets [n = 622]).

Three types of results are presented.

- Results for the stratified sample of school principals (622 respondents), weighted to produce statistically unbiased estimates.1
- Results for all school principals (3781 respondents), including those in the ANAO sample, weighted to produce statistically unbiased estimates.
- Results for all school principals (3781 respondents), unweighted.

Appropriate weighting is needed to ensure that no sub-set of the overall population is over-represented in the results. Weighting adjusts the raw survey data to ensure the results represent the views of the population as a whole, including for example certain stratum of the population that are under-represented in the responses received. In this case the weights were assigned to respondents according to what Education Authority they came from, to ensure that under-represented or over-represented Education Authorities, were represented appropriately in the overall results.
