The reports and supporting information are also published on the Finance website.

It is not possible to individually report on all items in the question as costs for domestic accommodation, food and incidental expenses are met by individual travellers from domestic travelling allowances paid at a daily rate.

In providing home department support for its portfolio Ministers, Finance did not incur any charges for security, gifts or entertainment associated with official travel.
