## **Question:**

## **Answer:**

The response only refers to information relating to the Department of the Prime Minister and Cabinet (PM&C) and covers the period 01 July 2010 to 16 June 2011. All cost information is from the department's financial management system. Newspapers and magazine costs are reported against the same general ledger item therefore year to date costs are combined in the response to part 2). To separate these figures would place an unreasonable burden on the department.

- 1. PM&C has a pay TV subscription with Foxtel. Through the subscription, the department provides staff with access to news channels to support departmental officers in the execution of their advisory role. The cost is \$1005 per month. The channels provided are:
