Senator Carr asked:

How many employees on a fixed term contract, for each year of the past six years, have been employed more than once on a fixed term contract? Please provide details of position classification in each instance.

Answer:

Due to limitations of the current Human Resource Management Information System used to administer the entitlements of staff employed the *Members of Parliament (Staff) Act 1984* (MOP(S) Act), the information sought has been extracted based on commencements in each financial year period.

The following tables provide details for non-ongoing MOP(S) Act employees who commenced any new periods of employment in the financial year as "specified period/task" employees (that is, excludes Casual Electorate Officers).

Please also refer also to information provided regarding non-ongoing employment in answer to Question 38F. Staff employed under the *Members of Parliament (Staff) Act 1984* (MOP(S) Act) are not employed under "fixed-term contracts". Prior to the introduction of the first MOP(S) Act staff Certified Agreement (CA) on 1 June 1999, staff were employed as either permanent or temporary. A response therefore cannot be provided for the financial years 1997/1998 and 1998/1999.

For ease of reference each employee in each year has been assigned an "employee number" (unique within each financial year only) in the following tables.
