When did the Department last update its procurement policy documentation?

#### Answer:

The Department regularly updates its procurement policy documentation to take into account new legislative requirements and improvements in business practice.

An update of the Operational Guidelines was released on 29 October 2004 to clarify issues on consultancies and non-consultancies and to provide more detailed instruction publishing public opportunities on AusTender. The updated Operational Guidelines also removed references to the former policy relating to industry development requirements and incorporated key information relating to procurement requirements which flow from the *Australian-United States of America Free Trade Agreement*, including a re-defining of appropriate procurement methods, explanations of key terms and listing the categories that will be exempt from the Mandatory Procurement Procedures.

On 24 December 2004, the Department issued its updated CEI on Procurement and the major update of the Operational Guidelines to incorporate all the requirements of the new procurement framework, as per the Commonwealth Procurement Guidelines - January 2005, which were released on 7 December 2004.

### Senator Murray asked:

At page 51 of ANAO Audit Report No. 10 2004-2005, *The Senate Order for Departmental and Agency Contracts (Calendar Year 2003 Compliance)*, the ANAO has concluded that all FMA agencies would benefit from implementation of contract training courses, or a review of current courses, to ensure that the Senate order requirements are adequately covered and that procurement staff receive relevant DOFA guidance.

What training does the Department currently have in place for procurement staff?

#### Answer:

The Department conducts regular training sessions for all staff on procurement policy and procedures. Sessions were conducted in October 2004 to introduce staff to the general requirements of the new Australian Government Procurement Framework.

Following the release of the Commonwealth Procurement Guidelines January 2005 on 7 December 2004, comprehensive training sessions have been conducted for officials in all Business Groups within the Department, to ensure that procurement processes conducted by Finance in 2005 meet all domestic and international obligations. The training has focussed on value for money outcomes, open competitive processes, meeting the mandatory procurement procedures for all covered procurement and on accountability requirements.

Yes. The public reporting requirements of the Department are reinforced in all training exercises. Specific reference is made to the detailed section within our Operational Guidelines (10.3.2 Listing of Agency Contracts) when procurement training is provided.

The Department has also provided bound versions of the February 2003 *Guidance on Confidentiality of Contractor's Commercial Information* to all SES officials, in order that they can readily make reference to all of the provisions.
