

#### Question 3.

The Department of Human Services technically comprises the core department, the Child Support Agency and CRS Australia. The budget and source of funding for the Child Support Agency and for CRS Australia remains unchanged by the creation of the Department.

The funding for the core department will be provided by transfers of appropriation under section 32 of the Financial Management and Accountability Act, from the Departments that use the services of the Human Services agencies. The details of these transfers are being negotiated by the Department of Finance and Administration and have not yet been finalised.

As at 25 January 2005, interim resource transfers totalling \$3.765 million for 2004-05 and \$3.900 million for 2005-06 and future financial years, have been agreed and transferred.

#### Question 4 and Question 5.

The Department of Finance and Administration has advised that the Australian Government response to the Uhrig Report was announced on 12 August 2004 by the Minister for Finance and Administration, Senator the Hon Nick Minchin. The Uhrig Report and the Government response were also tabled in the Parliament on 12 August 2004. Copies have been provided to the Senate Finance and Public Administration Legislation Committee.

Consistent with the Prime Minister's statement on 22 October 2004 the new Department of Human Services will ensure that the development and delivery of government services is placed under strong ministerial control with clear lines of responsibility through the Secretary of Human Services. This is in keeping with the Uhrig recommendations.

The Administrative Arrangements Order of 16 December 2004 provides the following:

***Matters dealt with by the Department***

Development, delivery and co-ordination of government services. Monitoring and management of service delivery and purchaser/provider relationships involving Centrelink, the Health Insurance Commission, the Child Support Agency, Australian Hearing, Health Services Australia and CRS Australia

***Legislation administered by the Minister***

*Australian Hearing Services Act 1991*, except to the extent administered by the Minister for Health and Ageing

*Child Support (Assessment) Act 1989*, insofar as it relates to the exercise of the powers and functions conferred on the Registrar under the Act

*Child Support (Registration and Collection) Act 1988*, insofar as it relates to the appointment of the Registrar and the exercise of the powers and functions conferred on the Registrar under the Act

*Commonwealth Services Delivery Agency Act 1997*

*Health Insurance Commission Act 1973*
