

DENMAN. Governor-General.

By His Excellency the Right Honorable Thomas, Baron Denman, a Member of His Majesty's Most Honorable Privy Council, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Knight Commander of the Royal Vic-torian Order, Governor-General and Commander-in-Chief of the Common-wealth of Australia.

HEREAS by the Quarantine Act 1908, it is enacted that the Governor-General may, by proclamation, appoint places on land or sea to be Quarantine Stations for the performance of quarantine by vessels, persons, goods, animals, or plants:

C.17356.

And whereas it is desirable to appoint a Quarantine Station for the quarantine of horses imported into the State of New South Wales:

Now therefore I, Thomas, Baron Denman, the Governor-Now therefore I, Thomas, Baron Denman, the Governor-General aforesaid, acting with the advice of the Federal Executive Council, do hereby appoint Mr. C. W. Perry's property at Ingleburn, consisting of about 850 acres, known as Leppington, situated within the municipal district of Campbelltown, New South Wales, about 30 miles from Sydney and 2½ miles from the Ingleburn Railway Station, southern line, and bounded by Denham Countlane, the main Camden-road, the Minto-road, and the properties of Messrs. Thomas and Thompson, to be a quarantine station for the performance of quarantine by horses imported into the State of New South Wales.

Given under my Hand and the Seal of the Common-wealth this 22nd day of December, One thousand nine hundred and eleven, and in the second year of His Majesty's reign.
