 - While it has no statutory powers or executive functions, it provides a forum for Secretaries and heads of major agencies to discuss significant issues of topical and long-term interest to the APS.
- 2) APEC aims to deliver a safe and successful APEC year in 2007. Its operational remit is to coordinate and manage the logistics of the APEC year. A governance framework for APEC 2007 has been established within which the Taskforce reports. It consists of key groups to provide guidance for strategic, operational and tactical level elements of planning for and delivery of the APEC year. Membership of these groups is drawn from senior officials from the Commonwealth, and in relation to planning for the leaders' week, New South Wales Government officials. The senior

- 8) The IDC coordinates development of a national emergency call centre capability.
- 9) The AGCTPC is the peak interdepartmental strategic policy coordination and information-sharing forum in the Australian Government on counterterrorism issues and developments.
- 10) The COAG Harmful Biological Material Working Group and the COAG Other Hazardous Substances (Chemicals) Working Group are working on identifying improvements to security regulation of biological material, radiological sources and chemicals.
- 11) Refer to 10) above.
- 12) The role of the OMSIG is to coordinate the implementation of government decisions arising from the report of the PM&C Taskforce on Offshore Maritime Security.

- 18) The CIU Reference Group act as an advisory group to the CIU, providing a range of perspectives and feedback on the Unit's operations and activities.
 - The reference group is advisory, consultative and collaborative; it does not have a decision-making role, nor are its recommendations binding on the CIU.
- 19) The aim of the IDC is to draw together the work of Australian Government agencies on pandemic preparedness to ensure complementarity and consistency of effort.
- 20) The Group provides advice to the Ministerial Taskforce on Indigenous Affairs on: directions and priorities in indigenous policy and expenditure; the performance of indigenous-specific and mainstream government programmes and services in improving outcomes for indigenous people; and resource allocation across the Australian Government for indigenous-specific programmes and services.
