PARLIAMENTARY DELEGATIONS – ANSWER TO QUESTIONS RAISED AT SENATE ESTIMATES HEARINGS

I refer to your email of 3 November 2006 in which you provide me with a copy of a letter from Mr Ian Harris, Clerk of the House, regarding evidence on parliamentary delegation travel provided to the Committee on Tuesday, 31 October 2006 by Ms Carolyn Hughes.

From examination of the Hansard evidence you will note that Senator the Hon Robert Ray raised the issue of travel warrants in a general question and that Ms Hughes' responses were couched in similar general terms. Ms Hughes did not have details of any specific delegation available at the hearing.

I note also that the Clerk of the House provided a copy of a letter from the Parliamentary Relations Office (PRO) to Ministerial and Parliamentary Services (M&PS) of 25 August 2006, advising of the official itinerary for the Parliamentary Delegation to South Africa from 29 September to 5 October 2006.

I am advised that M&PS did not proceed to issue travel warrants or calculate allowances as we became aware that there was to be a change in the official itinerary for one of the delegates. M&PS sought a copy of the revised itinerary in an email to the PRO on 18 September 2006 (copy attached). On 21 September 2006 the PRO replied by email advising of a variation to the official itinerary for Mr Stewart McArthur MP (copy also attached). The final itinerary for Mr McArthur was received on 26 September 2006.



Finalisation of this itinerary was the trigger for M&PS to issue travel warrants for all members of the delegation and prepare letters to delegates with details of allowance payments and other financial arrangements. Due to the lateness in finalising arrangements, these letters were provided to the Committee Secretary to distribute to delegates.

Ms Hughes' advice to the Committee appears to me to be correct and not require amendment.

In an endeavour to avoid delays in the future, M&PS proposes not to wait for the confirmation of the official itinerary for all delegates before providing letters of advice to individual delegates.

I would appreciate it if you could bring this letter to the attention of the Committee.
