- 1. What payment recipients are covert optical surveillance methods used on?
- 2. Provide details of the methods used, i.e. video camera or still camera, etc
- 3. Separately for the years 2004-05 and 2005-06 how many people in receipt of the Age pension were the subject of covert optical surveillance?
- 4. In 2005-06 how many people in receipt of the Carers payment were the subject of covert optical surveillance?
- 5. In 2005-06 how many people in receipt of Newstart were the subject of covert optical surveillance?
- 6. In 2005-06 how many people in receipt of the sole parent payment were the subject of covert optical surveillance?
- 7. In 2005-06 how many people in receipt of the parent payment partnered were the subject of covert optical surveillance?
- 8. In 2005-06 how many people in receipt of the Disability Support Payment were the subject of covert optical surveillance?
- 9. Separately for the years 2003-04, 2004-05 and 2005-06 indicate how many people have been the subject of covert optical surveillance?
- 10. Separately for the years 2003-04, 2004-05 and 2005-06 indicate how many cases of fraud were detected through the use of covert optical surveillance?
- 11. Which firms have been contracted to do the surveillance? In 2005-06 how much was spent in total on this type of activity?

Answer:

- 1. Optical surveillance can be used in relation to all payments administered by Centrelink.
- 2. Video and still photography, as well as visual observations.
- 3. In 2004-05, 122 people in receipt of Age Pension were the subject of optical surveillance.

In 2005-06, 118 people in receipt of Age Pension were the subject of optical surveillance.

- 4. In 2005-06, 45 people in receipt of Carers payment were the subject of optical surveillance.
- 5. In 2005-06, 861 people in receipt of Newstart were the subject of optical surveillance.
- 6. In 2005-06, 684 people in receipt of Parenting Payment Single were the subject of optical surveillance.
- 7. In 2005-06, 110 people in receipt of Parenting Payment Partnered were the subject of optical surveillance.
- 8. In 2005-06, 328 people in receipt of Disability Support Payments were the subject of optical surveillance.
- In 2003-04, 3,363 people were the subject of optical surveillance. In 2004-05, 2,577 people were the subject of optical surveillance. In 2005-06, 2,348 people were the subject of optical surveillance.
- 10. Optical surveillance is an evidence gathering tool and not a means of detection.

In 2005-2006, Centrelink spent \$1,251,696 on optical surveillance services.

To prepare this answer it has taken approximately 11 hours and 46 minutes at an estimated cost of \$608.
