Senator Ludwig asked: With regard to the preparation of Possible Parliament Questions briefs or other such documents intended to brief Minister's on an issue specifically for Question Time, could the department/agency provide:

- 1. The number of such briefs prepared in each of the last three financial years (2003-04, 2004-05, 2005-06).
- 2. The number of staff who are responsible for coordinating such briefs and the salary level they are engaged at.
- 3. The name of internal unit/team that those staff belong to and a description of its other responsibilities.
- 4. The total budget associated with the unit/team referred to in response to part 3.

Answer:

- 1. 2003-04 763; 2004-05 779 and 2005-06 1047.
- 2. Four one EL2, \$86,382 \$98,426; one EL1, \$74,215 \$82,733; one APS5, \$53,837 \$58,400 and one APS 3, \$43,496 \$46,841 (salary figures as at 1 October 2006)
- 3. Parliamentary Affairs and Legislation Section. The Section has a total of seven staff: two EL1s and one APS3 in addition to those mentioned earlier. Other responsibilities of the Section are:
- preparation of media summaries;
- monitoring of question time;
- coordination of responses to parliamentary questions on notice within the department and provision of advice to other portfolios on questions asked of all or multiple ministers;
- coordination of briefing material for the Prime Minister including speech and meeting briefs, and management of requests for messages from the Prime Minister;
- provision of advice on matters relating to the parliamentary departments and their Budget proposals:
- preparation of options for the annual parliamentary sitting pattern;
- provision of advice on parliamentary procedures and precedents;
