Question:

HS21a: Since July 2008, how many people have been breached and how many incurred eight week non-payment periods? Can you please provide breakdowns of the above numbers according to State, according to number of Indigenous persons by State and according to reason for breaching?

Answer:

HS21a: Participation Failures apply to job seekers who, without reasonable excuse, fail to comply with their Participation or Activity Test requirements. If a job seeker incurs three such failures within a twelve-month period they may be subject to an eight-week non-payment period.

Serious Failures apply to job seekers who, for example, leave suitable employment without reasonable excuse, or are dismissed from suitable employment for misconduct. Serious Failures may also result in an eight-week non-payment period.


The tables below provide a State-by-State breakdown of job seeker numbers for Participation and Serious Failures and eight-week non-payment periods applied including the reason for the Participation Failure or eight-week non-payment period.

Points to note:

- The column "Total Job Seekers" also includes the Indigenous Job Seeker numbers.
- The table "Participation and Serious Failures" includes all applied
 Participation Failure events, including those that did not result in an eightweek non-payment penalty noting that only Serious Failures or a third or
 more Participation Failure in a 12-month period will result in an eight-week
 non-payment penalty.
- A job seeker who has incurred one or more eight-week non-payment period penalties will be represented in both tables.

• To ensure that a job seeker is only counted once in each table, numbers have been attributed against a job seeker's most recent failure event. This may result in some discrepancies between tables for some failure reasons as there is not always a direct correlation between the most recent "Participation or Serious failure" event and the most recent "eight-week non-payment period" failure event.

 The figures provided represent job seeker numbers where a failure or an eightweek non-payment period has been "applied". This may differ from the number of customers who have "served" an eight-week non-payment period, due to the impact of review and appeal processes where a previously applied non-payment period is subsequently revoked.




