Senator Coonan—Is the NBN Co. required to prepare a statement of corporate intent?

Ms Hall—I would have to take that on notice.

Senator Coonan—Is there any reason why they would not?

Ms Hall—Some entities that are statutory authorities or statutory corporations are required to prepare statements—

Senator Coonan—Did you say 'are not required'?

Ms Hall—No, I said, 'are required'. Other entities that are GBEs but are not statutory corporations or statutory authorities, which NBN is not, are not required. So to give you a precise answer on that, I would prefer to take that on notice, if that is okay.

Answer:

As set out in the *Governance Arrangements for Commonwealth Government Business Enterprises (June 1997)* the directors of a wholly owned Government Business Enterprise and the Shareholder Ministers agree on a Statement of Corporate Intent (SCI), which is a public document. As NBN Co Limited (NBN Co) was prescribed as a Government Business Enterprise in 2009-10 it is not be required to prepare a SCI for that year. NBN Co will prepare a SCI for the 2010-11 financial year.

Answer:

Government Business Enterprises are (GBEs) required to prepare a Corporate Plan under the *Commonwealth Authorities and Companies Act* 1997 (CAC Act) (refer section 17 for Commonwealth authorities and section 42 for Commonwealth companies). Statements of Corporate Intent (SCIs) are a requirement for GBEs under the *Governance Arrangements for Government Business Enterprises* document. Some entities that are not GBEs also prepare SCIs, for example Snowy Hydro Limited.
