- e) Funding provided under both the National Recreation Safety Program and the 'Saving Lives in the Water' measure support the delivery of core water and snow safety programs aimed at reducing the number of aquatic and snow accidents and deaths in Australia.
- f) The organisations are required to provide the Department with progress reports as specified in the funding agreement/contract. These reports are provided quarterly to six monthly and detail how the projects are progressing and to ensure that milestones are being achieved.
- g) Yes.
- h) The National Recreation Safety Program is an ongoing program while element one of the 'Saving Lives in the Water' measure is an ongoing commitment subject to review in 2011-12 and element two is a lapsing commitment subject to review in 2011-12. The effectiveness of the individual programs and projects delivered by the various organisations are monitored and assessed through the reporting obligations of the funding agreements/contracts.
