For senior Executives, the standard may be included in their employment terms. The APSC's travel guide states that exceptions to the application of these standards can occur when an official is accompanying:

- a Minister;
- a member of the Executive or Group Manager where it is necessary for the official to work with or consult with the member; and
- an official government or foreign delegation where it is necessary for the official to provide advice, briefing or interpretation service.

Prior approval to upgrade the class of travel is required.
