Answer:

The Government does not generally disclose the content of legal advice received by the Government or its agencies. It is important for any government to be able to make fully informed decisions based on comprehensive and confidential legal advice. As such only total figures for legal service expenditure will be provided rather than a list of each service and costs. Expenditure for the period 1 July 2010 to 30 June 2011 includes expenditure by the Department from September 2010 for the Offices for the Arts and Sport. These offices were listed in the Department's responsibilities in the Administrative Arrangements Orders on 14 September 2010.

- 2. The Department's expenditure for legal services from the Australian Government Solicitor for the period 1 July 2010 to 30 June 2011 was \$881,900.
- 3. The Department's expenditure for legal services from private firms for the period 1 July 2010 to 30 June 2011 was \$182,267.
- 4. The Department's total legal service expenditure from other sources (Attorney-General's Department and counsel) for the period 1 July 2010 to 30 June 2011 was \$7,436.
- 5. The Department has spent approximately \$200,000 on internal legal services for the financial year to 31 October 2011.
- 6. Based on the Department's internal financial management system, the Department's expenditure for legal services for the financial year to 31 October 2011 from the Australian Government Solicitor is \$180,199.
- 7. Based on the Department's internal financial management system, the Department's expenditure for legal services for the financial year to 31 October 2011 from private firms is \$48,923.
- 8. Based on the Department's internal financial management system, the Department's expenditure for legal services for the financial year to 31 October 2011 from other sources is nil.
