In establishing the Indigenous Forum on Sustainable Economic Development, the requisite skills and experience for the positions of Chair and Deputy Chair were outlined for the Standing Committee of Senior Officials, which supports the Northern Australia Ministerial Forum, in an out-of-session paper.

These requirements included:

- Highly respected across northern Australia with demonstrated leadership skills.
 Able to provide high level leadership and gravitas to the Indigenous Experts
 Forum;
- Demonstrated ability to identify and engage key stakeholders in the business of the Indigenous Experts Forum;
- A depth of understanding of policy issues relevant to sustainable economic development in northern Australia;
- Excellent communication skills. Ability to lead and facilitate genuinely inclusive discussions at Forum meetings; and
- Extensive experience dealing with senior Ministers and officials. Able to
 efficiently and accurately communicate key messages from Forum meetings to a
 wide range of audiences.

On the basis of these requirements, the northern jurisdictions were invited to nominate suitable candidates to the Standing Committee. The Standing Committee considered three candidates. From this list, the Committee recommended Pat Dodson for the position of Chair and Peter Yu for Deputy Chair to the Ministerial Forum. These recommendations were considered and accepted by Ministers.
