For 2011-12, detail all education expenses (i.e. in house courses and tertiary studies) for each portfolio department and agency. Include what type of course, the total cost, cost per participant, the employment classification of each participant, how many participants and the amount of study leave granted to each participant (provide a breakdown for each employment classification). Also include the reason for the study and how it is beneficial for the department/agency.

Answer

DPS provides studies assistance support for ongoing and non-ongoing employees.

There are three categories of assistance are for:

- study directly related to the employee's duties (Category A);
- study that will assist an employee with their career development in DPS or the Parliamentary Service (Category B); or
- general study where the skills and knowledge will be some of assistance to an employee's current duties or assist in career development (Category C).

A maximum of 70 hours paid study leave is available to approved employees over one semester.

In 2011–12, a total of 31 employees were granted studies assistance.

- eighteen applications for study assistance directly related to the employee's duties (Category A);
- eight applications for study assistance assisted the employee with their career development in DPS and/or the Parliamentary Service (Category B); and
- five applications for study assistance were of assistance to an employee's current duties and career development (Category C).

Detail on the types of study that was undertaken in 2011–12 are detailed in Table 1 on the following page.

Other educational training that occurred outside of the studies assistance program for 2011–12 is detailed in Table 2.
