* The three methods of procurement, as defined by the Commonwealth Procurement Guidelines, which were in effect until 30 June 2012, are as follows:

Open—a procurement procedure in which a request for tender is published inviting all suppliers that satisfy the conditions of participation to submit tenders.

All consultancies listed as open were sourced from existing panel arrangements, which were previously tendered on the open market—with the exception of those marked ^, which were subject to a stand-alone open approach to market.

Select—a procurement procedure in which the procuring agency selects which potential suppliers are invited to submit tenders. Potential suppliers are selected from either a Multi-Use List, an Expression of Interest, or on the Basis of a Licence or Specific Legal Requirement.

Direct—refers to a procurement process in which an agency invites a potential supplier or suppliers of its choice to make submissions.

Total Value for all consultancies for the 2011–12 financial year: \$3,962,872(ex-GST).

In deriving the data for this question, DPS discovered some compilation and calculation errors which were not identified in its response to this matter in the DPS Annual Report. The DPS 2011–12 annual report incorrectly stated that 99 new consultancies with expenditure of \$4,610,713 (GST inclusive) were incurred. DPS will note an alteration for the 2012–13 annual report.
