Answer:

 Staff from the Department undertake travel in advance of, and accompany the Prime Minister to coordinate arrangements for the Prime Minister's overseas visits. During August and September 2012, the visits involved were the visit to Cook Islands from 29 to 30 August 2012, Russia from 7 to 9 September 2012 and New York, USA from 23 to 29 September 2012. Staff rarely accompany the Prime Minister or Portfolio Ministers on their travel for domestic events. The Department does not record travel data in a way that would readily allow such data to be identified. To attempt to provide this level of detail would involve an unreasonable diversion of departmental resources.

- 2. For the period 1 July 2012 to 30 September 2012, total travel and accommodation costs for the Department from departmental funds were \$573,858.45 (GST exclusive) for travel and \$148,543.83 (GST exclusive) for accommodation. These costs include \$38,161.20 of travel and accommodation expenses associated with management of the 2011 Commonwealth Heads of Government Meeting relating to the 2011-12 financial year. The Department does not record travel data in a way that would readily allow further breakdown of these figures. To attempt to provide this level of detail would involve an unreasonable diversion of departmental resources.
- 3. Yes.
- 4. The Department does not record lounge membership data in a way that would readily allow an answer to this question. To attempt to provide this level of detail would involve an unreasonable diversion of departmental resources. Lounge memberships for Qantas Club, Virgin Lounge and Regional Express are available to eligible employees. Memberships are only granted to employees who need access for work purposes.
