Answer:

- 1. The Department's spending on executive coaching and leadership training services totalled \$55,822 for the financial year to date.
- 2. All employees across all levels.
- 3. A total of 2 employees accessed leadership training services at the SESB1 level. A further 24 employees utilised executive coaching services with classifications ranging from APS3 SESB3.
- 4. The answers to question 4 a, c and 5 d are detailed in Table 1. The Department does not record leadership training and executive coaching data in a way that would readily allow answers to be provided to questions 4 b, 5e, 6, 7 and sub parts question. To attempt to provide this level of detail would be an unreasonable diversion of departmental resources.
