(a) Membership:

- (b) Duration of term:

(c) Terms of Reference and mission statement:

The RRAC advises the Minister for Immigration and Citizenship and the Parliamentary Secretary for Multicultural Affairs and Settlement Services on matters relating to the settlement of migrants and humanitarian entrants. In its fifth term, the key areas of focus for the Council are:

- monitoring the implementation of initiatives arising from the 2007-08 budget decisions by Government in relation to humanitarian entrants;
- improving the responsiveness of services across Government to the needs of migrants and humanitarian entrants;
- facilitating coordination and pathways between services across Government agencies and jurisdictions;
- addressing the challenges faced by new arrivals to promote their social and economic participation; and
- innovation, policy development and evaluation of specialised settlement services for humanitarian entrants.

Statement of Priorities 2008-2010

RRAC will provide advice on the development, provision and adequacy of initial settlement services relating to, inter alia;

- housing;
- complex case support;
- improving collaboration between service delivery organisations in the settlement sector;
- child protection including the welfare of unaccompanied humanitarian minors (UHMs);
- employment support, including skills recognition and connections with employers;
- pathways from English language to education and skills development;
- size and composition of the humanitarian program;
- health including mental health issues;
- support for youth who are at risk of disengaging from education and employment;
- language support, including interpreting services;
- settlement/resettlement nexus;
- diversifying settlement locations, both nationally and within urban centres;
- promoting the valuable contribution of migrants and humanitarian entrants;
- priorities for research on settlement issues;
- mobilising community and volunteer support for new arrivals; and
- information provision to new arrivals.

RRAC convenes up to three times a year. The Council also undertakes a number of out of session activities to further progress its Statement of Priorities. - provide independent advice to the Minister on policies, processes, services and programs necessary to achieve the timely, fair and effective resolution of immigration status for people seeking migration outcomes in Australia. This includes people whose immigration status is unresolved residing either in the community or in any form of detention. In particular, the Council will provide advice on:

 - the appropriateness and adequacy of services available to assist people whose immigration status is unresolved; and

(b) Duration of term:

The above members have been appointed for a one year term commencing 16 September 2009.

(c) Terms of Reference and mission statement:

The DeHAG will play a major role in providing the Department with the necessary independent, expert advice to design, develop, implement and monitor health care services for people in detention centres and related facilities.

The Department is reviewing the nature of detention services provision including health care services as a response to the Palmer and Comrie Reports. The delivery of primary health care and mental health services to people in detention will be a focus.

Specifically, the DeHAG will provide expert opinion regarding:

• the design, development and implementation of health policy for the health care, including mental health care, of people in immigration detention.

- appropriate health care service standards which should be achieved in detention health services.
- appropriate monitoring and reporting of detention health services and related information and data issues.
- the nature and scope of potential research required to facilitate improved health outcomes and management of health care in detention services.

The Detention Health Advisory Group will convene for an initial period of two years with an opportunity for members to review their position on an annual basis.
